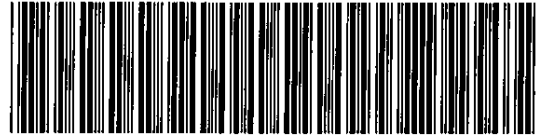

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Valkaria Area Neighborhood Association, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be:

The Board of Directors may from time to time move the principal office to another address in Florida.

The Board of Directors may from time to time change the mailing address to another address in Florida.

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

- A. To provide an organization whose purpose is to enhance the rural residential character of the Valkaria Area.
- A. To advise and coordinate actions by appropriate agencies concerning taxation, land use, and other uses of the Valkaria Area and its environs; to originate and coordinate fund raising activities through both public and private sectors of the community for committee approved projects.
- A. To protect the Valkaria Area from the intrusion of undesirable commercial and industrial interests.

- A. To advise and inform the Valkaria residents of future governmental proposals affecting the Valkaria Area and to provide a forum for the general protection and advancement of the residential qualities of the Valkaria Area.
- A. To ensure continuity of planning, execution and representation of Valkaria Area citizenry.
- A. To engage in any purpose within the meaning of Section 617.01 et seq. of the Florida Statutes.

ARTICLE IV COMMENCEMENT AND DURATION

This Corporation shall commence to exist at the time of the filing of these Articles of Incorporation by the Florida Secretary of State. This corporation's duration shall be perpetual.

ARTICLE V NUMBER OF DIRECTORS

This Corporation shall have not less than five (5) Directors. The number of directors may be increased or decreased from time to time, as provided in this corporation's bylaws, but shall never be less than three(3).

ARTICLE VI MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is stated in the By-Laws of the Corporation.

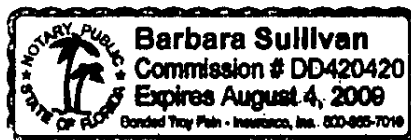
The Corporation reserves the right to amend or repeal any provisions in these Articles of Incorporation or any amendments hereto.
