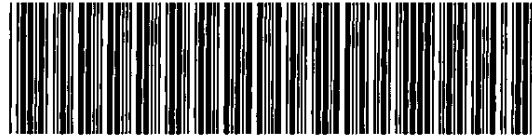

ARTICLES OF INCORPORATION  
FOR  
DAN ESTES MINISTRIES, INC.,  
A Florida Not-For-Profit Corporation

The undersigned subscriber to these Articles of Incorporation, an individual, hereby forms a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is the Dan Estes Ministries, Inc., hereinafter referred to as the "Corporation". The street address of the Corporation is 1802 Illinois Avenue, Lynn Haven, Florida 32444.

ARTICLE II - REGISTERED AGENT

The initial Registered Agent of the corporation is Dan Estes. The street address of the Registered Agent is 1802 Illinois Avenue, Lynn Haven, Florida 32444.

ARTICLE III - PURPOSES

The Corporation does not contemplate pecuniary gain or profit to its members. The Corporation shall have and exercise the following authority and powers:

- (a) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Corporation as set forth in the Bylaws, which is hereby incorporated by reference, as it may be amended from time to time.
- (b) To acquire, by gift, or otherwise, funds to be used in connection with the affairs of the Corporation.
- (c) To borrow any money and to mortgage, pledge or hypothecate any and all of its real or personal property as security for money borrowed or debts incurred.

ARTICLE IV - BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors. The Board of Directors shall be selected as provided in the Bylaws.

ARTICLE V - TERM OF EXISTENCE

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the provisions herein contained or in accordance with the laws of the State of Florida.

ARTICLE VI - DISSOLUTION

The Corporation may be dissolved as provided in the Bylaws.

ARTICLE VII - OFFICERS

Subject to the direction of the Board, the affairs of this Corporation shall be administered by its officers, as designated in the Bylaws of this Corporation. Said officers shall be elected annually by the Board in accordance with the Bylaws.

ARTICLE VIII - BYLAWS

The Bylaws of this Corporation shall be adopted by the first Board. The Bylaws may be altered, amended, modified, or repealed by a majority of the Directors.

ARTICLE IX - AMENDMENTS

The Corporation reserves the right to amend or repeal any of the provisions contained in these Articles by approval in writing by a majority of the Directors.

ARTICLE X - SUPREMACY



In the event of a conflict between the Articles and Bylaws, the Articles shall govern.
