

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the Corporation shall be THE PROVIDENCE BAPTIST
CHURCH OF PALATKA, FLORIDA, INC.

ARTICLE II - EXISTENCE

The Corporation shall have perpetual existence and its existence shall begin upon the approval of these Articles of Incorporation by the Secretary of State.

ARTICLE III - PURPOSE AND POWERS

The general purpose of the Corporation shall be to maintain and foster public worship, and the preachings and teachings of the Word of God and the Gospel of Jesus Christ. In furtherance of the above, the corporation shall be authorized to buy, purchase, or acquire by gift or devise, real and other property, to build, erect, construct, provide for, and maintain and equip suitable buildings, structures, churches, homes and parsonages for the use, benefit and occupation by the members of this Corporation, and of this Church. To carry out the above, and to provide for the financial ability to carry out the work by the Church and the Corporation, the Corporation shall be authorized to mortgage, issue notes or bonds, debentures and other evidence of debt, and to secure the same by mortgage, deed or trust, or otherwise.

ARTICLE IV - MEMBERSHIP

Members of the Corporation whose membership is current and in good standing shall also be members of The Providence Baptist Church. Failure to maintain a membership in good

standing shall result in a loss of membership in the Church and in the Corporation. Membership is further conditioned by provisions of the Corporation's by-laws.

ARTICLE V - OFFICERS

The corporation shall have no directors and its business shall be conducted by its officers.

The first officers of the Corporation and their addresses are:

It shall be permissible for one person to hold more than one office. The above officers shall serve until their successors are elected. The duties and responsibilities of the officers are set forth in the Corporation's by-laws.

ARTICLE VI - AMENDMENTS

These Articles of Incorporation and the Corporation's by-laws may be altered or amended at any regular or special meeting of the Corporation which has been duly and legally called and noticed. Any such alterations or amendments shall require the vote of 3/4 of the members present and attending said meeting.




