AMENDED ARTICLES OF INCORPORATION FOR SOLDIER UPGRADES INC.



Pursuant to the provisions of Section 617.1006, Florida Statutes (2006), SOLDIER UPGRADES INC., hereby adopts the following amendments and additions to its Articles of Incorporation:

- I. ARTICLE III of the Articles of Incorporation for SOLDIER UPGRADES INC., is hereby amended to read:
 - a. The specific purpose for which this corporation is organized is the purchase of and subsequent donation to soldiers of the United States armed forces of U.S. Military-approved equipment upgrades of all types that are or may not be provided to said soldiers by the United States Department of Defense due to supply or funding deficits. These upgrades will be donated to the recipient soldiers completely free of charge and will be entirely funded by charitable donations to this corporation.
 - b. This corporation is organized exclusively for charitable purposes, including, for such purpose, the making of distributions to organizations that qualify for exemption under Section 501(c)(3) of the Internal Revenue Code or any corresponding section of any future tax code.
- II. ARTICLE VII of the Articles of Incorporation for SOLDIER UPGRADES INC., is hereby amended to read:

- c. Betty Diaz, Vice President
- III. ARTICLE IX of the Articles of Incorporation for SOLDIER UPGRADES INC., is hereby ADDED:



No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) be a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

IV. ARTICLE X of the Articles of Incorporation for SOLDIER UPGRADES INC., is hereby ADDED:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent jurisdictions of the county in which the principal place of business of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

THE DATE of adoption of the above-listed amendments was August 28, 2006. The above-listed amendments shall become effective immediately.

THE ABOVE-LISTED amendments were adopted by the Board of Directors.

There are no members entitled to vote on the amendment.
