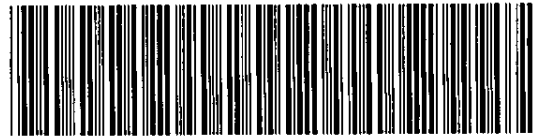

This corporation is organized exclusively for non- profit purposes and no part of any net earnings shall inure to the benefit of any member, director, or officer.
