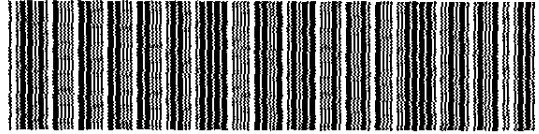

**ARTICLE I**

**Name**

The Name of this corporation shall be the "United Success", Inc. hereafter referred to as United Success, Inc.

**ARTICLE II**

**Principle Place of Business and Address**

The principle office of this corporation is in Tallahassee, Florida. The mailing address of the corporation is 3543 Sundown Rd., Tallahassee, Fl., 32305

**ARTICLE III**

**Purpose**

This program is organized and shall be operated exclusively for charitable purposes and qualify for tax exempt status under Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended, for the purpose.

The mission of United Success, Inc. is to instill strong moral character in young men who are in need of social support and character refinement through positive reinforcement while interacting with positive young men through team building.

**ARTICLE IV**

**Board of Directors**

The Board of Directors (Board) of United Success, Inc. shall be composed of both elected and appointed members. The elected members shall be the presiding officers and shall consist of a chair, vice-chair, secretary and treasurer.

The elected officers, along with the Executive Director of the program shall make up the Executive Committee of United Success, Inc. The elected officers shall be nominated from the seated Board with a term of office not to exceed two years and up to two consecutive terms. Nominations can or will be made by any elective or appointed Board member.

Appointed Board members will consist of association, organization, business, faith-base, and community representatives and shall be invited to sit on the Executive Committee with the approval Executive Director of United Success, Inc. The Board shall consist of not less that five and no more than fifteen members.

The Board of Directors shall be responsible for the development, management and control of the affairs, property and funds of the corporation and shall exercise all such powers and authority as expressly or by implication, conferred on them by these Articles of Incorporation, the by-laws of the corporation and the State of Florida.
