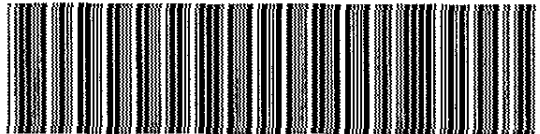

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I NAME**

D-Girls, Inc.

### **ARTICLE II PRINCIPAL OFFICE**

### **ARTICLE III PURPOSE**

D-Girls has been organized for charitable purpose of providing assistance to two target groups: disadvantaged women 20-29 and teen mothers.

Said organization (D-Girls, Inc) is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) and political campaign on behalf of any candidate for public office.

### **ARTICLE IV MANNER OF ELECTION**

Directors and officers will be appointed the first year. After first year, members will be able to challenge current directors and officers for their position. In the event that a challenge is offered, members will vote and person with most votes will be elected into the position.
