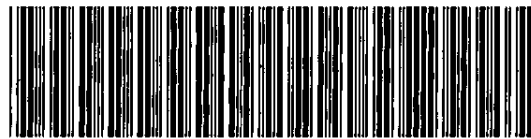



The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a non-profit corporation under the Florida Business Corporation Act (the "Act"), pursuant to Chapter 617 .0202, Florida Statutes and adopts the following Articles of Incorporation.

ARTICLE I
Corporate Name

The name of the corporation shall is **TechPossible Mission, Inc.**.

ARTICLE II
Principal Address

The principal place of business and mailing address of the corporation is 5470 East Busch Blvd., #104, Temple Terrace, FL 33617.

ARTICLE III
Purpose

The purpose for which this corporation is organized is solely and exclusively charitable, religious, educational, literary and scientific within the meaning of Section 501(c)(3) of the Internal Code as follows:

- A. To inform, teach and mentor at risk, inner-city youths and adults in the use of computer technology to reduce the Digital Divide.
- B. To provide an outreach ministry community technology center that equips youths and adults with computer skills to make a living and a spiritual foundation to make a life.
- C. To render aid and assistance to youths where possible in an effort to reduce the juvenile delinquency rate.
- D. To provide job-training and assistance to economically disadvantaged adults.
- E. To engage in any lawful business or activities related to the aforementioned charitable, religious, educational, literary and scientific purposes.

ARTICLE IV
Term of Existence

The corporation's existence commences on the date of filing of these Articles of Incorporation with the Florida Department of State, Division of Corporations. The corporation shall have perpetual existence hereunder.

ARTICLE IV
Initial Directors and/or Officers

The corporation shall have two (2) directors initially. The number of directors may be increased or decreased from time to time as provided in the Bylaws of the corporation, provided that the corporation will always have at least one (1) director. 
ARTICLE VI


ARTICLE VII
