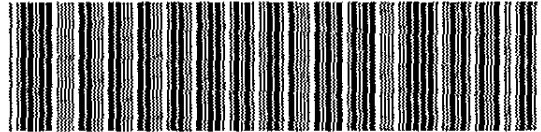

**Article IX Tax Exempt Clause**


