

Pursuant to the provisions of Sections 617.1001, 617.1002 and 617.1006 of the Florida Statutes, Good Shepherd Hospice, Inc., a Florida not for profit corporation, hereby adopts the following amendment to its Restated Articles of Incorporation (the "Restated Articles of Incorporation"):

- 1. <u>Name of Corporation</u>. The name of the corporation is Good Shepherd Hospice, Inc. (the "Corporation").
- 2. <u>Text of Amendment.</u>

For the sole purpose of identifying a <u>NEW STREET ADDRESS</u> for the Corporation, Article I of the Restated Articles of Incorporation is hereby amended by deleting it in its entirety and replacing it with the following:

# ARTICLE I NAME AND ADDRESS

The name of the corporation is Good Shepherd Hospice, Inc. (the "Corporation"). The street address of the Corporation's principal office is 3470 Lakeland Hills Boulevard, Lakeland, Florida 33805.
