# ARTICLES OF INCORPORATION OF BALDWIN'S GROVE HOMEOWNERS ASSOCIATION, INC., A CORPORATION NOT-FOR-PROFIT

The undersigned, by these Articles, associate themselves for the purpose of forming a not-for-profit corporation under Chapter 617, Florida Statutes, and certify as follows:

- Article 1. <u>Name</u>. The name of the Corporation is Baldwin's Grove Homeowners Association, Inc. For convenience, the Corporation shall be referred to in this instrument as the "Association."
- Article 2. Address. The address of the initial principal office of the Association and the initial mailing address of the Association is 1261 North Lake Sybelia Drive, Maitland, Florida 32751.
- Article 3. Definitions. All capitalized terms used in these Articles of Incorporation which are not defined herein shall have the meaning set forth in the Declaration of Covenants, Conditions, and Restrictions for Baldwin's Grove, recorded September 27, 1990 in official records Book 4222, Page 1833, Public Records of Orange County, Florida, as such Declaration may be amended from time to time (the "Declaration").
- Article 4. Purposes. The Association does not contemplate pecuniary gain or benefit, direct or indirect, to its members. The specific purposes for which the Association is formed are to be the Association as referenced in the Declaration of Covenants, Conditions, and Restrictions for Baldwin's Grove, recorded September 27, 1990 in official records Book 4222, Page 1833, Public Records of Orange County, Florida and provide for maintenance, preservation and architectural control of the area within that certain tract of land more particularly described in the Declaration and to promote the health, safety, and welfare of the residents within the property of the Association and any additions thereto as may hereafter be brought within the jurisdiction of this Association and for this purpose:
- (a) To be and constitute the Association to which reference is made in the Declaration, to perform all obligations and duties of the Association, and to exercise all rights and powers of the Association, as set forth in the Governing Documents and as provided by law;
- (b) To provide an entity for the furtherance of the interests of the owners of real property now and hereafter made subject to the Declaration (such real property is referred to in these Articles as the "Community"); and
- (c) To operate, maintain, and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. requirements and applicable District's rules, and to assist in the enforcement of the Declaration of Covenants, Conditions and Restrictions that relate to the surface water or stormwater management system.

The Association shall levy and collect adequate assessments against members of the

Association for the costs of maintenance and operation of the following:

- (i) Common Areas:
- (ii) Wall and landscape buffer areas:
- All landscaped areas outside the perimeter wall or walls, including (iii) conservation areas:
  - Retention areas; and (iv)
- All other areas which the Association in its reasonable judgment elects to (v) maintain.

In addition to the annual assessment authorized above, the Association may levy, in any assessment year, a special assessment applicable to that year only for the purpose of defraying, in whole or in part, the cost of any construction, reconstruction, repair or replacement of a capital improvement upon the Common Area, including fixtures and personal property related thereto, proved that any such assessment shall have the assent of two-thirds (2/3) of the votes of each class of members who are voting in person or by proxy at a meeting duly called for this purpose.

- Powers. In furtherance of its purposes, the Association shall have the Article 5. following powers, which, unless indicated otherwise by the Declaration or By-Laws of the Association, may be exercised by the Board:
- All of the powers conferred upon not-for-profit corporations by common law and (a) Florida statutes in effect from time to time: and
- All of the powers necessary or desirable to perform the obligations and duties and to (b) exercise the rights and powers set out in these Articles, the By-Laws, and the Declaration, including, without limitation, the following:
- To fix, levy, collect, and enforce payment of all charges or assessments authorized by the Declaration by any lawful means; to pay all expenses in connection therewith and all administrative and other expenses incident to the conduct of the business of the Association including, without limitation, all licenses, taxes, or governmental charges levied or imposed against the property of the Association;
- To manage, control, operate, maintain, repair, improve, and replace the common areas and facilities, and any property acquired by the Association, or any property owned by another for which the Association, by rule, regulation, declaration, or contract, has a right or duty to provide such services;
- To make rules and regulations and to enforce covenants, conditions, or restrictions affecting any property to the extent the Association may be authorized to do so under the

### Declaration or By-Laws;

- (iv) To engage in activities which will actively foster, promote, and advance the common interests of all owners of property subject to the Declaration;
- (v) To buy, or otherwise acquire, sell, or otherwise dispose of, mortgage, or otherwise encumber, exchange, lease, own, hold, use, operate, and otherwise deal in and with, real, personal, and mixed property of all kinds and any right or interest therein for any purpose of the Association;
- (vi) To borrow money for any purpose, subject to such limitations as may be contained in the Declaration and By-Laws;
- (vii) To enter into, make, perform, and enforce contracts of every kind and description, and to do all other acts necessary, appropriate, or advisable in carrying out any purpose of the Association, with or in association with any other corporation, entity, or agency, public or private;
- (viii) To act as agent, trustee, or other representative of other corporations, firms, or individuals, and as such to advance the business or ownership interests in such corporations, firms, or individuals;
- (ix) To adopt, alter, amend, and repeal the By-Laws as may be necessary or desirable for the proper management of the affairs of the Association; provided, however, such By-Laws may not be inconsistent with or contrary to any provisions of the Declaration; and
- (x) To provide any and all supplemental municipal services to the Community as may be necessary or desirable.

The foregoing enumeration of powers shall not limit or restrict in any manner the exercise of other and further rights and powers which may now or hereafter be allowed or permitted by law; and the powers specified in each of the paragraphs of this Article 5 are independent powers, not to be restricted by reference to or inference from the terms of any other paragraph or provision of this Article 5.

Article 6. Members. The Association shall be a membership corporation without certificates or shares of stock. There shall be two classes of membership, Class "A" and Class "B", however, Class "B" membership has ceased and converted into Class "A" membership in accordance with the Declaration. The Owner of each Lot shall be a member of the Association and shall be entitled to vote as provided in the Declaration and the By-Laws.

Change of membership in the Association shall be established by recording in the Official Records of Orange County, Florida, a deed or other instrument establishing record title to real property subject to the Declaration. Upon such recordation, the owner designated by such instrument shall become a member of the Association and the membership of the prior Owner shall terminate.

- Existence and Duration. Existence of the Association shall commence with the filling of these Articles of Incorporation with the Secretary of State of the State of Florida. The Association shall exist for a term of fifty (50) years.
- Article 8. Board of Directors. The Association's business and affairs shall be conducted, managed, and controlled by a Board of Directors ("Board"). The Board may delegate its operating authority to such companies, individuals, or committees as it, in its discretion, may determine.

The Board shall consist of three (3) members, as provided in the By-Laws. The names and addresses of the initial directors, who shall hold office until their successors are elected and have qualified, or until removed, are as follows:

The method of election and removal of directors, filling of yacancies, and the term of office of directors shall be as set forth in the By-Laws.

- By-Laws. The By-Laws shall be adopted by the Board and may be altered. Article 9. amended, or rescinded in the manner provided in the By-Laws.
- Article 10. Liability of Directors. To the fullest extent that the Florida Not-for-Profit Corporation Act, as it exists on the date hereof or as it may hereafter be amended, permits the limitation or elimination of the liability of directors, no director of the Association shall be personally liable to the Association or its members for monetary damages for breach of duty of care or other duty as a director. No amendment to or repeal of this Article shall apply to or have any offect on the liability or alleged liability of any director of the Association for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal.

#### Article 11. Indemnification.

Indemnity. The Association shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, or investigative, by reason of the fact that he or she is, was, or has been elected or appointed a director, employee, officer, or agent of the Association. Such indemnification shall include indemnification against expenses (including, without limitation, attorney's fees and appellate attorney's fees), judgments, fines, and amounts paid in settlement, actually and reasonably incurred by the indemnified person in connection with such action, suit, or proceeding, if such person acted in good faith and in a manner he or she reasonably believed to be in or not opposed to the best interest of the Association, and, with respect to any criminal action or proceedings, such person had no reasonable cause to believe his or her conduct was unlawful. Notwithstanding the foregoing, no indemnification shall be made in respect of any claim, issue, or matter as to which such person shall have been adjudged to be liable for gross negligence, misfeasance, or malfeasance in the performance of his or her duty to the Association, unless, and then only to the extent that, the court in which such action or suit was brought shall determine upon application that despite the adjudication of liability, in view of all of the circumstances of the case. such person is fairly and reasonably entitled to indemnification for such expenses as such court shall deem proper. The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendre or its equivalent shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he or she reasonably believed to be in or not opposed to the best interest of the Association, and with a respect to any criminal action or proceeding, had reasonable cause to believe that his or her conduct was unlawful.

- Approval. Any indemnification under paragraph (a) above (unless ordered by a court) shall be made by the Association only as authorized in the specific case upon a determination that indemnification is proper under the circumstances because the person requesting indemnification has met the applicable standard of conduct set forth in paragraph (a) above. Such determination shall be made (i) by majority vote of the members of the Board who were not parties to such action, suit. or proceeding, if sufficient to constitute a quorum, or (ii) if a quorum of the Board is not obtainable. or, even if obtainable, if a quorum of disinterested directors so directs, in a written opinion rendered by independent legal counsel engaged by the Association, or (iii) by a majority vote of the Members.
- Advances. Expenses incurred in defending a civil or criminal action, suit, or proceeding may be paid by the Association in advance of the final disposition of such action, suit, or proceeding as authorized by the Board in any specific case upon receipt of an undertaking by or on behalf of the affected director, officer, employee, or agent to repay such amount if it is ultimately determined that he or she is not entitled to be indemnified by the Association as authorized in this Article.
- Miscellaneous. The indemnification provided by this Article shall not be deemed exclusive of any other rights to which those seeking indemnification may be entitled under the Bylaws, or any agreement, vote of Members, or otherwise, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs and personal representatives of such person.
- Insurance. The Association shall have the power to purchase and maintain insurance on behalf of any person who is or was a director, officer, employee, or agent of the Association, as a director, officer, employee, or agent of another corporation, partnership, joint venture, trust, or other enterprise, against any liability asserted against him or her and incurred by him or her in any such capacity, or arising out of his or her status as such, whether or not the Association would have the power to indemnify him or her against such liability under the provisions of this Article.

#### Article 12. Interested Directors.

No contract or transaction between the Association and one or more of its directors or (a)

officers, or between the Association and any other corporation, partnership, or Association, or other organization in which one or more of its directors or officers are directors or officers have a financial interest shall be invalid, void, or voidable solely for such reason, or solely because the director or officer is present at or participates in the meeting of the Board at which such contract or transaction was authorized, or solely because his, her, or their votes are counted for such purpose. No director or officer of the Association shall incur liability by reason of the fact that he or she is or may be interested in any such contract or transaction.

- **(b)** Interested Directors may be counted in determining the presence of a quorum at a meeting of the Board at which a contract or transaction with an Interested Director is to be considered.
- Amendments. Amendments to these Articles of Incorporation may be Article 13. proposed and adopted upon a resolution duly adopted by the Board and the affirmative vote or written consent of Members representing at least 75% of the Members in the Association. No amendment may be in conflict with the Declaration. However, no Members shall be entitled to vote on any amendment to these Articles of Incorporation made for the sole purpose of complying with the requirements of any governmental (including, without limitation, the U.S. Department of Housing and Urban Development ("HUD") or the U.S. Department of Veterans Affairs ("VA")) or quasi-governmental entity or institutional lender authorized to fund, insure, or guarantee Mortgages on Lots, as such requirements may exist from time to time, which amendments the Board may adopt by majority vote.
- Dissolution. The Association may be dissolved only upon (a) a resolution Article 14. duly adopted by the Board, and (b) the affirmative vote of members who are Owners of not less than two-thirds (2/3) of the Lots. Upon dissolution of the Association, if VA is guaranteeing or HUD is insuring the Mortgage on any Lot, then unless otherwise agreed in writing by HUD or VA, any remaining real property of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that acceptance of such dedication is refused, such assets shall be granted, conveyed, and assigned to any nonprofit corporation, association, trust, or other organization to be devoted to such similar purposes. Such requirement shall not apply, if VA is not guaranteeing and HUD is not insuring any Mortgage; provided, however, that, if either agency has granted project approval for the Community, then such agency shall be notified of such dissolution.

In the event of the Association's termination, dissolution, or final liquidation, the responsibility for the operation and maintenance of the surface water and stormwater management system must be transferred to and accepted by an entity which complies with Section 40C-42.27, F.A.C. and is approved by the St. Johns River Water Management District prior to such termination, dissolution, or liquidation.

Incorporator. The name of the incorporator of the Association is David M. Article 15. Conway, and such incorporator's address is 1261 North Lake Sybelia Drive, Maitland, Florida 32751.

Article 16. Registered Agent and Office. The initial registered agent of the Association is David M. Conway, and the initial registered agent's office is 1261 North Lake Sybelia Drive, Maitland, Florida 32751.
