ARTICLE I  
NAME

The name of the Corporation is: FLEMING ISLAND PRESBYTERIAN CHURCH, INC.

ARTICLE II  
ADOPTION OF DISSOLUTION

The Corporation has no members, other than Presbytery of St. Augustine, Inc., who are entitled to vote on the dissolution of the Corporation. The board of directors of the Corporation, which is currently comprised of seven (7) trustees, adopted a resolution by unanimous written consent dated November 28, 2018, authorizing and approving the dissolution of the Corporation in accordance with the provisions of Sections 617.0821 and 617.1401, Florida Statutes. Presbytery of St. Augustine, Inc., as the sole member of the Corporation having voting rights with respect to the dissolution of the Corporation, adopted a resolution by written consent dated November 28, 2018, authorizing and approving the dissolution of the Corporation in accordance with Sections 617.0701 and 617.1401, Florida Statutes.

ARTICLE III  
EFFECTIVE DATE

The effective date of these Articles of Dissolution shall be the date the Articles of Dissolution are filed by the Secretary of State of the State of Florida.


