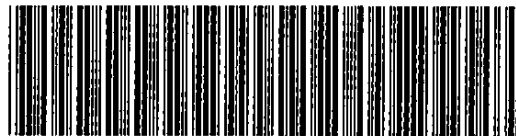

(A NOT-FOR-PROFIT CORPORATION)**

ARTICLE I: *NAME*

The name of the Not-For-Profit Corporation shall be the **SOUTH FLORIDA CATEGORY FIVE FOOTBALL TEAM, INC.**

ARTICLE II: *PRINCIPAL OFFICE*

ARTICLE III: *PURPOSE AND POWERS*

This Non-Profit Corporation is organized for the purpose of transacting any or all lawful business and shall have all of the corporate powers enumerated in the Florida Not for Profit Corporation Act.
