

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617.0202, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I. The name of this corporation shall be **Promised Provision Ministries, Inc.**

ARTICLE II The principal place of business of this corporation shall be:

5321 Watson Road, Riverview, FL 33569

The mailing address for this corporation shall be:

P.O. Box 6237, Brandon, FL 33508-6004

ARTICLE III The purposes for which this corporation is organized are: To work with individuals, religious groups, civic groups, governments and the private sector to accomplish the following objectives:

- A. To promote religious teaching and pastoral training through the construction, maintenance, operation and promotion of churches, the purchasing, producing, publishing and distributing of religious materials, the teaching and training of pastors, church leaders and teachers, the provision of resources required to enable them to travel as necessary, and the providing of support to existing churches and their leaders in Haiti and in the Haitian community within the United States. This is intended to include providing support to pastors, church leaders, and teachers requiring assistance to conduct the travel necessary to accomplish their work.
- B. To establish, maintain, promote and operate a centralized communication system through which individuals, religious groups, civic groups, governments and the private sector can network resources to individuals in Haiti and within Haitian communities within the United States.
- C. To construct, establish, maintain, promote and operate educational/vocational facilities in Haiti and within Haitian communities within the United States that promote quality educational and vocational programs vital to preparing individuals to become self-sufficient and break the cycle of poverty.
- D. To establish, distribute, promote and monitor/oversee scholarships, grants and loans to Haitian students of all ages in Haiti and within Haitian communities within the United States.
- E. To construct, establish, maintain, and promote programs to protect individuals in Haiti and within Haitian communities within the United States from exploitation, violence, and abuse and to create protective, healthy, nurturing environments vital to their survival, health, and well-being which fortify them from harm.
- F. To construct, establish, maintain, promote and operate food distribution and medical facilities in Haiti and within Haitian communities within the United States in order to provide comprehensive systems of family-oriented health care to nutritionally and medically underserved areas in Haiti and within the Haitian community in the United States.

- G. To establish, maintain, promote and operate national and international adoption programs in Haiti and within Haitian communities within the United States which provide stable, loving families for orphaned, abandoned, abused or otherwise displaced children.
- H. To establish, maintain, promote and operate eldercare facilities in Haiti and within Haitian communities within the United States to provide stability and care for elderly people in underserved areas.
- I. To research, develop and implement the potential of water projects such as crops irrigation, well digging, etc. in underserved areas in Haiti.
- J. To assess the need for and provide for disaster preparedness and disaster/emergency relief in Haiti and within Haitian communities within the United States.
- K. To conduct fundraising activities in support of the foregoing objectives.

ARTICLE IV The board of directors shall be comprised of three to five (3-5) directors. The manner in which the directors shall serve will be:

Each director shall hold office until his/her successor qualifies and is appointed by the President.




