ARTICLES OF INCORPORATION

OF

BAKERSFIELD COMMUNITY ASSOCIATION, INC.

# (Corporation Not For Profit)

In compliance with the requirements of Chapter 617 of the Florida Statutes, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a corporation not for profit.

#### **ARTICLE I**

The name of the corporation is Bakersfield Community Association, Inc. ("the Association").

### **ARTICLE II**

The street address of the initial principal office and the mailing address of the Association is 8386 Austin Road, Melrose, Florida 32666.

#### **ARTICLE III**

The purposes for which the Association is organized is to operate and manage the Bakersfield subdivision in accordance with the Declaration of Covenants, Conditions, Restrictions and Easements For Bakersfield as recorded in the Public Records of Clay County, Florida, as may be amended from time to time ("the Declaration"), and to exercise all powers, authority and discretion provided to the Association in the Declaration.

#### ARTICLE IV

The street address of the Association's initial registered office is 420 South Lawrence Blvd., Keystone Heights, Florida 32656. The initial registered agent for the Association at that address is James J. Taylor Jr.

#### ARTICLE V

The name and street address of the incorporator is James J. Taylor Jr., 420 South Lawrence Blvd., Keystone Heights, Florida 32656.

#### ARTICLE VI

The method of election of the directors of the Association shall be stated in the bylaws of the Association and shall be consistent with the provisions in the Declaration regarding election of directors.

#### ARTICLE VII

The Association shall indemnify its directors and officers to the fullest extent permitted by law.

#### ARTICLE VIII

The Association shall be perpetual in existence. It shall be a condition to the dissolution of the Association that prior to such dissolution any stormwater management system operated or maintained by the Association must be transferred to, and responsibility for operation and maintenance thereof must be assumed by, an entity acceptable to the St. Johns River Water Management District.

#### **ARTICLE IX**

The corporate existence of the Association shall begin on July 28, 2006.
