# ARTICLES OF INCORPORATION

# OSCEOLA GREEN PROPERTY OWNER'S ASSOCIATION, INC.

The undersigned, acting as incorporator, does hereby ador following Articles of Incorporation, pursuant to Chapter Florida Statutes:

### ARTICLE I

The name of the corporation shall be OSCEOLA GREEN PROPERTY OWNER'S ASSOCIATION, INC., with its initial principal place of business at 180 Pelican Way, Panacea, FL 32346 and with a Post Office address of 180 Pelican Way, Panacea, FL 32346, and with Joshua Erich Brown being its initial registered agent at said address.

### ARTICLE II

The corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation with the Secretary of State, The Capitol, Tallahassee, Florida 32399.

### ARTICLE III

The purpose of the corporation shall be to maintain the common areas within OSCEOLA GREEN including but not limited to the stormwater facility, with OSCEOLA GREEN, being more particularly described in Exhibit "A" attached, and to perform all acts necessary and incident thereto as may be legal under the laws of the State of Florida and of the United States of America.

Each lot owner within said subdivision shall be a member of this corporation, with each lot being entitled to one vote, with a majority of the lots constituting a quorum, and with all business of the corporation being transacted upon a majority vote of the lots constituting said quorum or being otherwise present.
