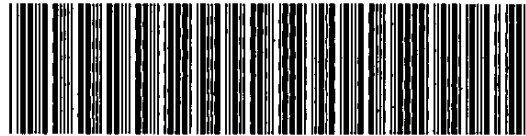

Articles of Incorporation of the undersigned, a majority of whom are residents of the State of Florida in the United States of America, desiring to form a Non-Profit Corporation pursuant to the Non-Profit Corporation Law of the State of Florida, do hereby certify that:

ARTICLE I

The name of the Non-Profit Corporation shall be:

FORUM QUALITY CARE SERVICES, INC.

ARTICLE II

The place in the state of Florida where the principle office of the non-profit corporation is to be initially located is 6430 N.E. 21ST Road, Fort Lauderdale, Fl 33308.

ARTICLE III

Said Corporation is formed exclusively for charitable, education, religious, and scientific purposes, including, for such purposes, the making of distributions to such organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future tax code. The specific purposes of the corporation is to provide: social services for elderly, disabled and HIV/AIDS individuals including, but not limited to, compliance monitoring, consultation, home health care, referral services, housing/residential services, and relief of poverty/homelessness assistance.

ARTICLE IV

Any director of the Forum Quality Care Services must posses at a bachelor's degree. The Corporation shall have board members and directors. The qualifications, obligations and the rights of the members and directors of the Corporations are spelled out in the Bylaws of the Corporation

ARTICLE VIII

No part of the net earnings of the corporations shall inure to the benefit of or be distributed to its officers, trustees, members or any other private persons, except that the corporation shall be empowered and authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Article 3 hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign including the distribution or publishing of statements on behalf of or in opposition to any candidate running for public office. Notwithstanding any other provision of the Articles herein, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in the furtherance of the purposes of the Corporation

ARTICLE IX

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes pursuant to § 501 (c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code, shall be distributed to the state, local or Federal government specifically for public purpose. Any such asset not so disposed, shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is currently located, exclusively for such purposes or to such organization, as said Court determine, which are operated exclusively for such purposes.

ARTICLE X

The period and duration of the Corporation is perpetual.

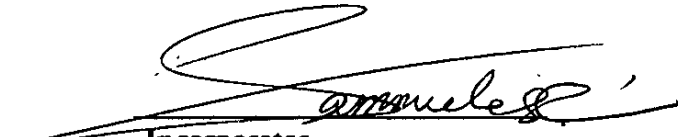
