

SECOND ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

SEBASTIAN VILLAGE CONDOMINIUM RESORT ASSOCIATION, INC.

Pursuant to the Provisions of Section 617.1006 and in accordance with Article 13 of the Articles of Incorporation of SEBASTIAN VILLAGE CONDOMINIUM RESORT ASSOCIATION, INC., a Florida Not For Profit corporation (the "Corporation"), the Corporation hereby adopts the following amendment to its Articles of Incorporation in order to comply with the requirement of the St. Johns River Water Management District.

1. ARTICLE 7 is amended in its entirety to read as follows:

The Association shall have perpetual existence. In the event of termination, dissolution or final liquidation of the Association the responsibility of the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

This amendment was adopted by the Board of Directors of the Corporation on this 25 day of 5000, 2009.
