#### A Florida Corporation Not For Profit

The undersigned incorporator of these Articles files same for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of this corporation is CITRUS WOODS HOMEOWNERS' ASSOCIATION OF CITRUS COUNTY, INC.. For convenience, the corporation shall be referred to in this instrument as the "association", these Articles of Incorporation as the "articles" and the bylaws of the association as the "bylaws."

## ARTICLE II INITIAL PLACE OF BUSINESS

The initial place of business of the Association shall be 320 U.S. Highway 41 South, Inverness, FL 34450.

#### ARTICLE III TERM OF EXISTENCE

The association shall have perpetual existence.

#### ARTICLE IV PURPOSE

The purpose and objects of the corporation are such as authorized under Chapter 617 of the Florida Statutes and specifically include the ownership, maintenance, preservation, administration

and management of certain lands and improvements serving homeowners in the development known as CITRUS WOODS, located in Citrus County, Florida. This homeowners' association is also incorporated pursuant to Chapter 720, Florida Statutes. This corporation is organized and operated solely for administration and managerial purposes. It is not intended that the corporation show any net earnings, but no part of any net earnings that do occur shall inure to the benefit of any private member.
