ARTICLES OF INCORPORATION of LIFE LESSONS OVER LUNCH, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the corporation is Life Lessons Over Lunch, Inc.

The corporation shall exist perpetually unless dissolved according to Florida law.
