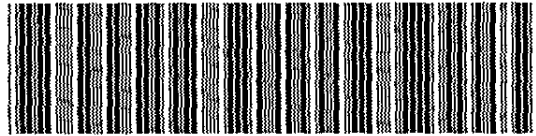

ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION

EVANGELISTS FOR JESUS TABERNACLE, INC., a Florida Not-For-Profit corporation, under its corporate seal and hands of its President, WILLIAM G. SANDS, and Secretary, LOVE JOY SANDS, hereby certifies that on the 22 day of January, 2007, the Board of Directors by proper corporate action amended the Articles of Incorporation of EVANGELISTS FOR JESUS TABERNACLE, INC., which is an amendment on which Members are not entitled to vote, as follows:

RESOLVED, that the undersigned, constituting all of the Directors eligible to vote, do hereby sign this statement manifesting their intention to amend the Articles of Incorporation of EVANGELISTS FOR JESUS TABERNACLE, INC., as filed in the Office of the Secretary of State on the 7th day of August, 2006.

RESOLVED, that Article VIII of the Articles of Incorporation be added so as to read as follows:

ARTICLE VIII.

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

BE IT FURTHER RESOLVED, that the Articles of Amendment shall be executed by the Corporation, by its President and by its Secretary, and filed in the Office of the Department of State as anticipated by Section 617.01201 Form 607.0120, Florida Statutes.

IN WITNESS WHEREOF, said Corporation has caused these Articles of Amendment to be signed in its name by its President, and its corporate seal to be hereunto affixed and attested by its

Secretary, this 22nd day of January, 2007.

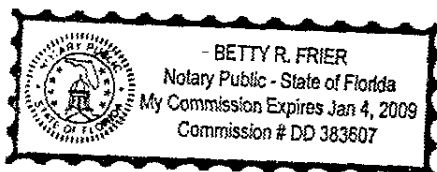
