This Firm represents Sts. Peter and Paul Russian Orthodox Greek Catholic Church of Miami, Florida, Inc, Document No. N06000008342 (the "Corporation"). The following persons were added as members and/or officers to the Corporation without its or its members' knowledge or consent in false and fraudulent reports filed on September 1, 2023, and September 14, 2023: (1) Joseph Lucas, (2) Robert Brookes. (3) Bernard Peter Robichau, II, (4) Marcus Burch.

Mr. Lucas, Brookes, Burch, and Robichau are not nor have ever been affiliated with the Corporation, and their addition as members and/or officers of the Corporation was fraudulently entered when filing an Amendment and Name Change, then an Amendment.

The enclosed Statement of Fact has been duly signed and notarized in accordance with Florida Statutes §817.155. Given the importance and sensitive nature of this issue, we ask that you enter the Statement of Fact to the record as a matter of public notice for the Corporation. STATEMENT OF FACT

The undersigned hereby certify, under penalty of perjury, and notify the Florida Department of State (the "Department") that they wish to stipulate the following facts with respect to Sts. Peter and Paul Russian Orthodox Greek Catholic Church of Miami, Florida, Inc. (the "Corporation"):

- 1. On September 1, 2023, an Amendment and Name Change was filed with the Department for Sts. Peter and Paul Russian Orthodox Greek Catholic Church of Miami, Florida, Inc, Document No. N06000008342. ('Amendment 1')
- 2. Then on September 14, 2023, another Amendment was filed with the Department for Sts. Peter and Paul Russian Orthodox Greek Catholic Church of Miami, Florida, Inc, Document No. N06000008342. ('Amendment 2')
- 3. The filing of Amendment 1 and Amendment 2 was not authorized and was filed without the knowledge or consent of any genuine member of the Corporation.
 - 4. The unauthorized fraudulent changes in Amendment 1 are as follows:
 - a. Name change of the Corporation.
 - b. Change of mailing address.
 - c. Change of registered agent of the Corporation.
 - d. Removal of all genuine officers and directors: Priscilla Rivera (Warden), Randy Homyk (Treasurer and Registered Agent), Philip Reese (President)
 - e. Addition of fraudulent officers and directors: Rev. Dr. Joseph Lucas (new President), Robert Brookes (new Treasurer)
 - 5. The unauthorized fraudulent changes in Amendment 2 added are as follows:
 - a. Addition of fraudulent officer and directors: Bernard Peter Robichau II (new Secretary) and Marcus Burch (new Director)
- 6. Both Amendment 1 and Amendment 2 were filed by Rev. Dr. Joseph Lucas without the approval required by the relevant bylaws associated with the Articles of Incorporation.
- 7. Rev. Dr. Joseph Lucas is well aware of the bylaws associated with the Articles of Incorporation and chose to disregard their requirements in an attempt to usurp power from the rightful officers and members of the Corporation.
- 8. Rev Dr. Joseph Lucas, Robert Brookes, Bernard Peter Robichau II, and Marcus Burch are not and nor have ever been atfiliated with the Corporation. None were authorized to be

added to the Corporation, or to make any changes to the Corporation's name, mailing address, officers, directors, or registered agent per the Articles and relevant bylaws of the Corporation.

- 9. On or around September 26, 2023, the Corporation filed an Amendment to correct the record and reflect only the true members of the company, namely Priscilla River and Randy Homyk.
- 10. Amendment 1 and Amendment 2 filed September 1st and 14th of 2023, respectively, constitute false, fictitious, or fraudulent statements in a matter within the jurisdiction of the Department, as described in Florida Statutes §817.155.
