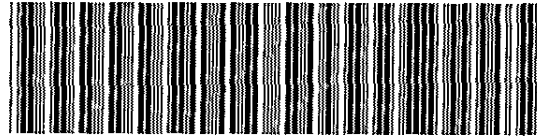

I. NAME; ADDRESS; This corporation shall be known as Rising Faith in Christ Ministries, Inc.. The mail address of the corporation is

2. PURPOSE; MEMBERS; This church corporation is organized under Chapter 617 Florida Statutes, the "Florida Not For Profit Corporation Act," for the purpose of religious worship and related acts of faith as an independent, Pentecostal, Full Gospel Ministry. Membership is open to all persons of Christian faith who accept the By-laws, Doctrine and Mission of the church.

3. POWERS; TERM: The corporation shall be empowered to do all things consistent with the laws of the State of Florida. The corporation shall have perpetual existence.

4. TRUSTEES: a Board of Trustees of not less than three (3), nor more than seven (7) persons shall be elected or appointed as provided in the by-laws of the corporation. The incorporators shall serve as the initial Board of Trustees.

conducting routine business or as otherwise provided in by-laws.


8. FISCAL YEAR: The calendar year shall be the fiscal year of the corporation.

10. AMENDMENTS: These Articles of Incorporation and the By-laws, Doctrine, Mission and other governing documents of the church may be amended by three (3) trustees then in office after written notice to the trustees setting forth the proposed amendments and their written consent thereto.

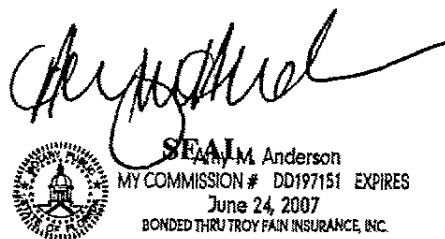
11. SEAL: The corporate seal shall be the Christian symbol of the Cross.


