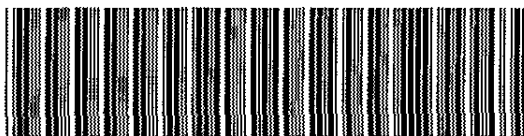

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation in accordance with the laws of the State of Florida for philanthropic purposes in accordance with Florida Statutes Section 617, as a auxiliary organization for the STAR CENTER, INC., a school for children with autism and related disorders.

**ARTICLE I.- NAME**

The name of this corporation is STAR CENTER FOUNDATION, INC.

**ARTICLE II.-NATURE OF CORPORATION**

The general nature of the business to be rendered by this corporation is to assist raising funds for the school operated by the STAR CENTER, INC. which teaches children with autism and related disorders. In order to promote its purpose, the Corporation may acquire property by grant, devise, or bequest and hold and dispose of such property as the Corporation shall require for the benefit of the members and purposes of the Corporation and not for pecuniary profit.

**ARTICLE III.-TERM OF EXISTENCE**

This corporation shall have perpetual existence.

#### ARTICLE VIII - DISSOLUTION

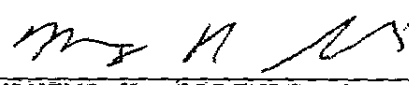
In the event of a dissolution of this Corporation, the

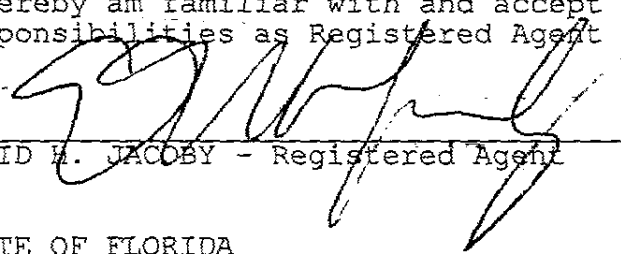

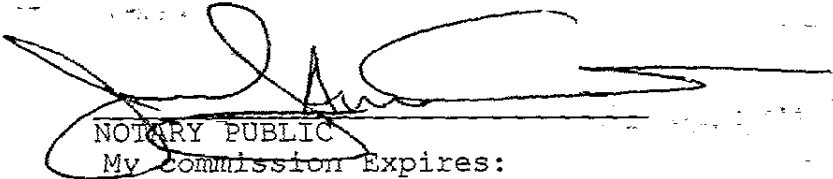

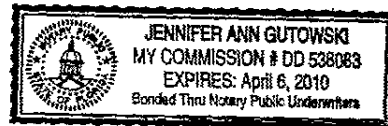
