**ARTICLES OF INCORPORATION
IN COMPLIANCE WITH CHAPTER 617, F.S. (NOT FOR PROFIT)**

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE:

HORIZONS OF HOPE, INC.

ARTICLE II PRINCIPLE OFFICE

- A. THE PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE LOCATED IN THE CITY OF ORLANDO, FLORIDA. THE ORGANIZATION MAY HAVE SUCH OTHER OFFICES, EITHER WITHIN OR WITHOUT THE STATE OF FLORIDA AS THE BOARD OF DIRECTORS MAY DETERMINE FROM TIME TO TIME.
- B. THE MAILING ADDRESS FOR THIS ORGANIZATION IS SUITE 271, 4524 CURRY FORD, ORLANDO, FL 32812. THE ORIGINAL REGISTERED AGENT OF THE ORGANIZATION IS AT THIS ADDRESS OF THE DIRECTOR TERI ARNDT.

ARTICLE III PURPOSE

HORIZONS OF HOPE INC., IS ESTABLISHED, ORGAINED, SHALL EXIST AND BE OPERATED EXCLUSIVELY FOR RELIGIOUS, CHARITABLE, DISTRIBUTION, EDUCATIONAL AND EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE LAW.

A. THE SPECIFIC AND PRIMARY PURPOSES OF THIS ORGANIZATION ARE:

- (1) TO CONDUCT OUTREACHES BY THE DIRECTION OF THE LORD, JESUS CHRIST AND UNDER THE LEADERSHIP OF THE HOLY SPIRIT IN ACCORDANCE WITH ALL OF THE COMMANDMENTS AND PROVISIONS AS SET FORTH IN THE HOLY BIBLE. AND TO ESTABLISH OTHER OUTREACHES
- (2) TO PROMOTE AND MAINTAIN OUTREACHES, MISSIONS IN THE STATE OF FLORIDA: TO PROMOTE FELLOWSHIP AND MEANS OF COOPERATION BETWEEN OTHER OUTREACHES, CHURCHES AND INDIVIDUALS OF LIKE FAITH, AND DOCTRINES TO SPREAD THE GOSPEL THROUGH MEANS OF DISTRIBUTION THROUGH ALL LAWFUL MEANS.
- (3) TO PROMOTE AND ENCOURAGE, THROUGH THE MINISTRY OF THE ORGANIZATION, COOPERATION WITH OTHER ORGANIZATIONS MINISTERING WITHIN THE COMMUNITY
- (4) SPREAD THE WORD OF RELIEF AND GOSPEL THROUGH SEMINARS, RADIO AND OTHER FORMS OF MASS MEDIA FOR THE PURPOSES OF EDUCATING THE INDIVIDUAL ON THE GOSPEL.
- (5) TO DISTRIBUTE DONATIONS IN DISASTERS FOR RELIEF. TO NETWORK WITH OTHER ORGANIZATIONS IN ORDER TO MEET THE NEEDS SPIRIT, SOUL AND BODY TO NEEDY INDIVIDUALS AT HOME AND ABROAD.
- (6) TO ACQUIRE AND HOLD SUCH PROPERTY, EITHER REAL OR PERSONAL, FOR OUTREACH AND CHARITY PURPOSES, AS MAY BE NECESSARY FOR THE OPERATION AND ORGANIZATION OF THIS COOPERATION.

- (7) TO MAINTAIN AND ESTABLISH BIBLE SCHOOLS, TRAINING SCHOOLS, FOR EDUCATIONAL PURPOSES, AND ORDAIN QUALIFIED MINISTERS FOR THE CONTINUANCE OF THE OUTREACH.
- (8) TO INAUGURATE AND MAINTAIN CHARITABLE INSTITUTIONS, HOMES FOR THE AGED, AND REST HOMES FOR MINISTERS, AND MISSIONARIES, ORPHANAGES, AND HOMES FOR THE INDIGENT. TO EDUCATE THOSE BOUND BY SUBSTANCE AND OTHER ABUSE WITH SCHOOLS, KINDRED INSTITUTIONS. AND TO PROVIDE CHRIST CENTERED EDUCATION FOR THE CHILDREN IN THOSE COMMUNITIES.
- (9) TO MAINTAIN SUCH RELATIONS WITH LOCAL, STATE, FEDERAL AND FOREIGN GOVERNMENTS AS MAY BE NECESSARY FOR THE SUCCESSFUL ACCOMPLISHMENTS OF THE PURPOSES OF THE ORGANIZATION AND FOR THE WELFARE OF THE OUTREACHES, MINISTERS AND MEMBERS THEREOF
- (10) TO ENGAGE SUCH EMPLOYEES AS MAY BE NECESSARY TO PERFORM THE DUTIES INVOLVED IN CARRYING ON THE ORGANIZATIONS BUSINESS.
- (11) TO RECEIVE CONTRIBUTIONS AND DONATIONS AND TO DISPENSE THESE CHARITABLE CONTRIBUTIONS AND DONATIONS THROUGH, AND OTHERWISE AID AND SUPPORT, THOSE ORGANIZATIONS QUALIFIED FOR EXEMPTION FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, AS NOW IN EFFECT OR SUBSEQUENTLY AMENDED.
- (12) TO ESTABLISH AND OPERATE FACILITIES WITHIN COMMUNITIES USED FOR DISTRIBUTION OF FOOD, AND OTHER SUCH ITEMS AS NEEDED TO HELP FAMILIES BECOME ESTABLISHED WITHIN THE COMMUNITY

(B) THE GENERAL PURPOSES AND POWERS OF THE ORGANIZATION ARE TO:

(1) ACCEPT, RECEIVE, HOLD, SELL, RE-INVEST, AND DISPOSE OF GIFTS, DONATIONS, DEVICES, AND BEQUESTS OF BOTH REAL AND PERSONAL PROPERTY. TO PURCHASE, ACQUIRE, OWN, HOLD SELL, USE, MORTGAGE, TRANSFER, PLEDGE, AND DEED IN TRUST PERSONAL OR REAL PROPERTY; TO SUPERVISE PROPERTY OF OTHERS; TO BORROW MONEY; TO ISSUE BONDS, DEBENTURES, NOTES, AND OTHER OBLIGATIONS OF THIS ORGANIZATION FROM TIME TO TIME FOR ANY OF THE PROJECTS OR PURPOSES OF THIS ORGANIZATION. TO BUY, LEASE, RENT, OR OTHERWISE ACQUIRE, HOLD OR USE, OWN ENJOY, SELL, EXCHANGE, LEASE AS LESSOR, MORTGAGE, DEED TRUST, PLEDGE, ENCUMBER, TRANSFER ON WHETHER REAL, PERSONAL, OR MIXED, AND TO RECEIVE PROPERTY BY DEVISE OR BEQUEST. TO BORROW MONEY AND TO CONTRACT DEBTS, TO ISSUE BONDS, NOTES, AND OTHER EVIDENCES OF INDEBTEDNESS, AND TO SECURE THEM BY ANY OR ALL OF THE PROPERTY TO THIS ORGANIZATIONS OF TO ISSUE THEM UNSECURED. TO ENTER INTO, MAKE, PERFORM, AND CARRY OUT CONTRACTS OF EVERY KIND FOR ANY LAWFUL PURPOSE AND WITHOUT LIMIT ON AMOUNT WITH ANY PERSONS FIRM CORPORATION OR ASSOCIATION. TO HAVE AND EXERCISE ALL THE POWERS CONFERRED BY THE LAWS OF THE STATE OF FLORIDA UPON NON-PROFIT RELIGIOUS ASSOCIATIONS, AS THAT LAW IS NOW IN EFFECT OR MAY AT ANY TIME HERAFTER BE AMENDED.

(2) A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE. (OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW) OR

(3) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 (C) (2) OF THE INTERNAL REVENUE CODE. (OR CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

(C) THE BOARD OF DIRECTORS MAY CAUSE THE CORPORATION TO SOLICIT, COLLECT, RECEIVE, ACCUMULATE, ADMINISTER AND DISBURSE FUNDS IN SUCH MANNER AS WILL, IN THE SOLE DISCRETION OF THE BOARD OF TRUSTEES, MOST EFFECTIVELY OPERATE TO FURTHER THE PURPOSES OF THE CORPORATION.

(D) UPON DISSOLUTION OF THE CORPORATION, THE BOARD OF DIRECTORS SHALL, AFTER PAYING OR MAKING PROVISION OF THE PAYMENT OF ALL THE ASSETS OF THE CORPORATION EXCLUSIVELY FOR THE PURPOSES OF THE CORPORATION IN SUCH MANNER, OR TO SUCH ORGANIZATION OR ORGANIZATIONS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, RELIGIOUS, OR SCIENTIFIC PURPOSES AS SHALL AT THE TIME QUALIFY AS AN EXEMPT ORGANIZATION OR ORGANIZATIONS AND "PUBLIC CHARITY" UNDER SECTIONS 501 (C) (3) AND 509 (A) (1) OF THE INTERNAL REVENUE CODE, OR TO AN ORGANIZATION CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 (C) (2) OF SUCH CODE AND REGULATIONS AS THEY NOW EXIST AS THEY MAY HEREAFTER BY AMENDED, AS THE BOARD OF TRUSTEES SHALL DETERMINE ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DONATED TO SUCH CORPORATION OR CORPORATIONS, ASSOCIATIONS.

ARTICLE IV MANNER OF ELECTION

ITS BOARD OF DIRECTORS SHALL MANAGE THE AFFAIRS OF THIS ORGANIZATION. THE DIRECTORS NEED NOT BE RESIDENTS OF FLORIDA, NOR NEED THEY BE MEMBERS OF THE ORGANIZATION.

THE NUMBER OF DIRECTORS CONSTITUTING THE INITIAL BOARD OF DIRECTORS OF THE ORGANIZATION IS THREE (3). THE INITIAL BOARD OF DIRECTORS SHALL HOLD OFFICE UNTIL THE FIRST BUSINESS MEETING FOR THE ELECTION OF DIRECTORS OR UNTIL THE RESPECTIVE SUCCESSORS TO SUCH DIRECTORS SHALL BE ELECTED. THE NUMBER OF DIRECTORS MAY BE FIXED OR CHANGED FROM TIME TO TIME ONLY BY AN AMENDMENT TO THE BYLAWS OF THE ORGANIZATION.

THE FIRST ANNUAL BUSINESS MEETING OF THE ORGANIZATION SHALL BE HELD AT A TIME AND PLACE BY THE BOARD OF DIRECTORS AT WHICH TIME THE ORGANIZATION SHALL ADOPT BYLAWS FOR THE INTERNAL GOVERNMENT OF THE ORGANIZATION AND ELECT DIRECTORS OF THE ORGANIZATION.
