ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a not for profit Corporation under and by virtue of the laws of the State of Florida, adopts the following as the Articles of Incorporation of Winter Springs High School Drama Booster Association, Inc.

ARTICLE I

NAME, ADDRESS, DURATION, REGISTERED OFFICE AND AGENT

- (a) The name of the Corporation is Winter Springs High School Drama Booster Association, Inc., hereinafter referred to as "Corporation".
- (b) The address of the principal office and mailing address of the corporation is 1340 Tuskawilla Road, Winter Springs, Florida 32708.
- (c) The existence of the Corporation will be perpetual.
- (d) The initial registered office of the Corporation will be located at 1340 Tuskawilla Road, Winter Springs, Florida 32708
- (e) The initial registered agent of the Corporation at that address is Grace Anne Glavin, Esquire.

ARTICLE II

PURPOSE

The purpose for which the Corporation are formed, and the business and objects to be carried on and promoted by it are as follows:

- (a) To promote and maintain a non-profit organization, that will provide managerial and financial support for the various drama activities of the Winter Springs High

School Drama Program.

ARTICLE III

POWERS

The Corporation is empowered:

- (a) To do all lawful things necessary to carry out the purposes stated in Article II.
- (b) To have all the corporate powers enumerated in the Florida Not For Profit Corporation Act not inconsistent with these articles and appropriate for not for profit corporations.

ARTICLE IV

DIRECTORS

The number of directors of the Corporation shall be as provided in the Bylaws; however, the number of directors shall not be less than three. The directors shall be elected as provided in the Bylaws. The directors of the Corporation must at all times be members of the Corporation. The original directors, and the terms for which each will serve, are set forth below.

ARTICLE V

MEMBERSHIP

The manner of admission and the grounds for termination of membership in the

Corporation shall be as provided in the Bylaws.

ARTICLE VI

OFFICERS

The Corporation shall have those officers described in, and elected in the manner provided by, the Bylaws.

In the event of dissolution of the Corporation, the residual assets of the Corporation will be distributed to one or more organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify it as an exempt organization under Section 501©)(3) of the Internal Revenue Code.
