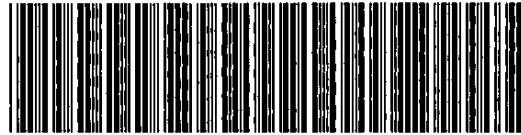



ARTICLES OF INCORPORATION

FOR

SAINT CLOUD AVENUE FIRST CHURCH OF GOD, INC.

The undersigned, a majority of whom are citizens of the United States, acting as incorporators of a non-profit corporation pursuant to Chapter 617, Florida Statutes adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: Saint Cloud Avenue First Church Of God, Inc.

ARTICLE II PRINCIPAL OFFICE

The street address of the initial principal office and the mailing address of this corporation shall be: 2210 Durant Rd. Valrico, FL 33594 .

ARTICLE III PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Said corporation is a church under the authority of the Church Of God Ministries.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: The method of election of directors is stated in the by laws.

ARTICLE VI REGISTERED AGENT AND ADDRESS

The name and the street address of the initial registered agent is: Jimmy E. Pope, 208 N. Mobley St., Plant City, FL 33563.

ARTICLE VII INCORPORATOR(S)

The name(s) and street address(es) of the incorporator(s) for these Articles of Incorporation is (are): Jimmy E. Pope, 208 N. Mobley St., Plant City, FL 33563

ARTICLE VIII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of

the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X

This corporation will be subordinate to and subject to the authority of the Church Of God Ministries of Anderson, IN
