#### **ARTICLE XII**

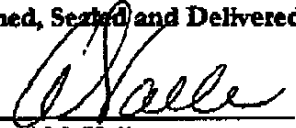

ARTICLE XIV

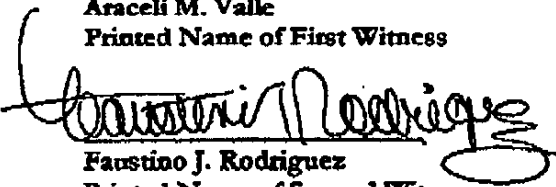
