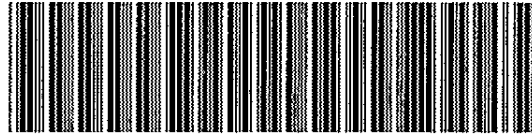

ARTICLES OF INCORPORATION

of

ELIZABETH MISSIONARY BAPTIST CHURCH OF ORANGE MILLS, INC.

The undersigned, pursuant to the Provisions of Section 617.0202 of The Florida Statutes does hereby and herewith file, with the Secretary of State of The State of Florida, these Articles of Incorporation for ELIZABETH MISSIONARY BAPTIST CHURCH OF ORANGE MILLS, INC., a Corporation Not for Profit organized pursuant to the Laws of The State of Florida.

ARTICLE I.

The Name of the Corporation is and shall be ELIZABETH MISSIONARY BAPTIST CHURCH OF ORANGE MILLS, INC.

Article II.

The street address of the initial principal office of the Corporation is 117 Gladys Ave., East Palatka, FL 32131 and the initial mailing address for the Corporation is the same.

Article III.

The purposes for which the Corporation is organized is for the propagation of the Christian Faith, for the preaching of the Gospel of Jesus Christ, for the evangelizing of the world and for any other purpose or purposes for which a Florida Corporation Not For Profit may be organized and/or operated under the Laws of The State of Florida.

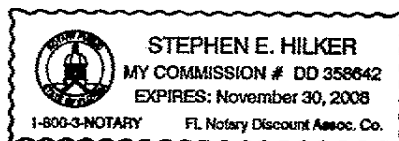
