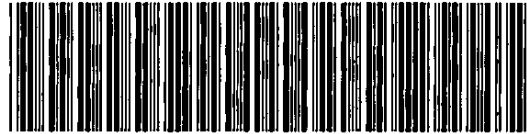



ARTICLE VIII DISSOLUTION OF ASSETS

Upon the dissolution of the Corporation, the assets and property of the Corporation remaining after expenses and liabilities have been paid shall be distributed, as determined by the Board of Directors, for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
