ARTICLE I NAME

The name of the corporation shall be:
Iglesia Cristiana Pentecostal de Clermont, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
405 Main Street Minneola, FL

ARTICLE III PURPOSE

The corporation is organized in order to provide religious worship and instruction, churches, schools, missions, and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that people may be generally instructed and guided concerning these articles of faith which are most surely held among Pentecostal Churches and to advance spiritual growth and enlightenment, moral and personal purity among people, to promote home and foreign missions, and to aid in the spread of the Gospel of Jesus Christ.

This church is a nonprofit corporation organized and operated exclusively for religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, as now enacted or hereafter amended (or corresponding section of any future federal tax code.

The church shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Code or (b) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Code. This church has not been formed for pecuniary profit or gain. No part of the assets, income, or profits of the church shall inure to the benefit of its members, council members, trustees, or officers or to any individual. However, the church shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III.

No substantial part of the activities of this church shall consist of carrying on propaganda, or otherwise attempting to influence legislation. This church shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV MANNER OF ELECTION

The corporation shall have one or more classes of members, as provided in the corporation's bylaws. Directors are elected by the active members of the church.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

There shall be five members of the initial board of directors of the corporation. The names and addresses of the persons are:
