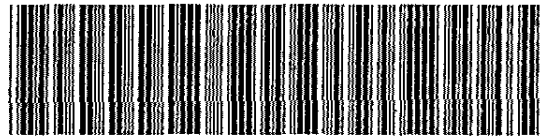

**ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S.; (Not for Profit)

**ARTICLE I      NAME**

The name of corporation shall be:
