

Articles of Amendment Being Added.

Purpose Clause:

"This corporation My Brother And Sister's Keeper Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code"

Dewer Clause:

"Notwithstanding any provision of these articles, the corporation My Brother And Sister's Keeper Inc. shall not carry on any other actives not permitted to carried on (a) by a corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Code of 1986 (or corresponding provision any corresponding provision of any future United States Internal Revenue Law)."

Dissolution Clause:

"Upon the dissolution of this corporation My Brother And Sister's Keeper Inc., assets shall be distributed for one or more exempt purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code, or shall be distributed Federal government, or to a state or local government, for a public purpose. Any Count of Competent Jurisdiction of the county in with the principal office of the corporations then located, exclusively for such purposes or such organization or organizations, as said Count shall determine, which are organized and operated exclusively for such purposes."
