# ARTICLES OF INCORPORATION Liance with Chapter 617, F.S., (Not for Profit)

# **Article I. Name of Corporation**

The name of the Corporation shall be: U.S.C.O.T. Research Inc.

# **Article II. Statement of Corporations Nature**

This is a nonprofit foundation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act set forth in Part I of Chapter 617 of the Florida Statutes.

# Article III. Principle Office

The principle place of business & mailing address of this Foundation shall be: 2220 N.W. 55<sup>th</sup> BLVD. #31 Gainesville, Florida 32653

# Article IV. Purpose

The specific and primary purposes for which this corporation is formed are to operate for the advancement of sustainable science research and for other charitable purposes, and particularly for cooperative endeavors among the sustainable research staff of the U.S.C.O.T. Research Inc. community.

The general purposes for which this corporation is formed are to operate exclusively for such sustainable research purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as tax-exempt organizations under that Code.

This corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

The corporation will eventually create a sustainable living environment promoting an ecologically balanced subterranean self contained community. To be sustainable under the worst conditions earth may offer including terrorism and world war. To create many internal community research centers for sustainable living using experts from different sustainable fields.

The corporation will create internal subterranean industrial foundries to provide everything the community needs. It will also create an internal educational/scientific information network for its members. The corporation will, at some point, donate its' scientific findings to the world for humanitarian purposes.

The corporation will create a safe haven for advanced knowledge from this era. The final goal is to have the information to rebuild society with the highest level of technology and sustainability if it is needed.

#### Article V. Manner of Election

The manner in which the directors are elected or appointed: The directors were picked from a list of people from which the incorporator had contact. These people had an interest in science and sustainability. They were chosen because they agreed with the ideals of which the corporation stands

## Article VI. Management of Foundation affairs

- (a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by the board of directors. The number of directors of the foundation shall be three; provided, however, that such number may be changed by a bylaw duly adopted by the members.
- (b) The directors named in Article Eight shall hold office until the first annual meeting of members to take place after incorporation. Prior to that meeting, an election of directors shall take place, according to provisions of the bylaws of the corporation.

# Article VII. Membership

The corporation shall have a membership distinct from the board of directors. Membership is institutional, and is open to any research scientist or expert in the field of sustainability in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Virginia or West Virginia and to any University or Research lab located in the United States of America including Puerto Rico, and the District of Columbia, working off dues as provided within the bylaws and agreeing to be bound by the articles of incorporation of this corporation, by its bylaws, and by such rules and regulations as the directors may form time to time adopt. The directors shall from time to time prescribe the form and manner in which application may be made for membership.
