RESOLUTION

"KNOW ALL MEN BY THESE PRESENTS that a nonprofit corporation under the name of LIONS CLUB OF ST. PETERSBURG INC. was organized and duly chartered by the Circuit Court of Pinellas County, Florida, and since that time has operated and done business as a nonprofit corporation.

"Since that time the said corporation has purchased Lots Seven (7), Eight (8), Sixteen (16), Seventeen (17), Eighteen (18), Block Eight (8) of Sawyer and Barrell's Second Addition to Boca Gaige Pass Subdivision, and has erected buildings and structures thereon, and has been in actual, open and notorious possession of said lands for a period of more than seven (7) years, and by error of the scrivener or in some other unexplainable manner, title to the said lands was taken in ST. PETERSBURG LIONS CLUB, a corporation. This corporation is the actual owner of said property, paid the consideration therefor, paid for and erected the improvements thereon and has been in actual possession thereof since that time.

"In order that the name of the owner corporation coincide with the manner in which title to the said lots was acquired, it is the desire of the corporation to change its corporate name to ST. PETERSBURG LIONS CLUB, a corporation.

"NOW THEREFORE, BE IT RESOLVED that the corporate name of LIONS CLUB OF ST. PETERSBURG INC. be changed to ST. PETERSBURG LIONS CLUB, a corporation, and one of the circuit judges in and for Pinellas County, Florida, be requested to enter an order accordingly."

KNOW ALL MEN BY THESE PRESENTS that I, Carlos E. Shepard, the duly authorized and empowered Secretary of Lions Club of St. Petersburg Inc. have compared the above resolution with the original records in my hands and I certify that it is a true and correct copy of a resolution adopted on the 8th day of June, 1951.

ARTICLES OF INCORPORATION

LIONS CLUB OF ST. PETERSBURG, INC.

The undersigned incorporators hereby associate themselves together for the purpose of forming a corporation not for profit, under and by virtue of the laws of the State of Florida, with and under the following proposed charter.

ARTICLE I

The name of the corporation shall be LIONS CLUB OF ST. PETERSBURG, INC. and shall be located in Pinellas County, Florida.

ARTICLE II

The general nature of the object of this corporation shall be for the promotion of charitable blind work and other benevolent or charitable work of the Lions Club of St. Petersburg, Florida, and for the general entertainment of the members of the Lions Club of St. Petersburg, Inc.

ARTICLE III

All members of the Lions Club of St. Petersburg, a civic club affiliated with Lions International, Florida, shall be members of the Lions Club of St. Petersburg, Inc.

ARTICLE IV

The Lions Club of St. Petersburg, Inc. shall have a perpetual existence unless sooner dissolved according to law or the laws of their charter from Lions International, which shall have the right to change its name.

ARTICLE V

The affairs of the Lions Club of St. Petersburg, Inc. shall be managed by a president, two vice-presidents, a secretary, a treasurer, a tall twister and Lion tamer, such officers shall automatically be members of the board of directors; and a board of directors of 5 members in addition to such officers. All officers and directors shall be elected at an annual meeting to be held on the last Friday in June of each year.

ARTICLE VI

The by-laws of the Lions Club of St. Petersburg, Inc. shall be made and approved by the board of directors at their first meeting, and may be altered or rescinded by a vote of a majority of the board of directors, and 2/3 of its membership.

ARTICLE VII

The highest amount of indebtedness or liabilities to which the Lions Club of St. Petersburg, Inc. may at any time subject itself shall never be greater than two-thirds of the value of the property of the corporation, and at no time may be greater than 10000.00. The highest amount in value of the real estate which the Lions Club of St. Petersburg, Inc. may hold shall be \$25,000.00.

ARTICLE VIII

The names of the officers and directors who are to manage the affairs of the Lions Club of St. Petersburg, Inc. until the first annual election to be held as herein provided shall be as follows:
