Articles of Incorporation

The undersigned, acting as incorporator of a non-profit corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

Article I

The name of the corporation shall be:
Wellington Wicked Fastpitch Softball, Inc.

Article II

The principal place of business and mailing address of this corporation shall be David Hir, 200 Berenger Walk, Wellington, FL 33414.

Article III

The specific purpose for which the non-profit corporation is organized is to establish certain amateur fast pitch softball teams for girls. Wellington Wicked Fastpitch Softball Inc. will practice, train and ultimately compete in girl's fast pitch softball tournaments.

The corporation shall have the power to engage the services of such persons or organizations to assist it in carrying out such purposes. In addition the corporation shall have all the powers granted pursuant to the Statutes of the State of Florida.

The directors shall be appointed at the sole discretion of the incorporator, David Hir.

There shall be no limitation of corporate powers except as provided by law
