



Pursuant to the provisions of Florida Statute §617.0202, the undersigned incorporator hereby makes, subscribes, acknowledges, and files these Articles of Incorporation.

**ARTICLE I
NAME**

The name of this Corporation shall be **RC ADVANCED SHUTTERS SYSTEMS ASSOCIATION, INC.**

**ARTICLE II
PRINCIPAL OFFICE**

The principal office and mailing address of this Corporation shall be **2805 N.W. 75th Avenue, Miami, Florida 33122.**

**ARTICLE III
NATURE OF BUSINESS**

This Corporation is being formed to establish a shutters trade association in order to comply with governmental requirements.

**ARTICLE IV
TERM OF EXISTENCE**

INDEMNIFICATION


