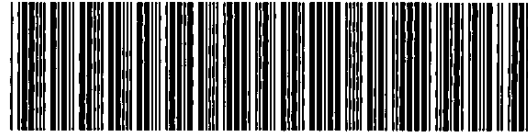





ARTICLE I – NAME

The name of this organization is: Feed My Sheep Ministry of God, Inc.  
(EIN 05-0578470)

ARTICLE II – PRINCIPLE OFFICE

The principal place of business is: 237 Fairfield Drive, Sanford, Florida 32771

ARTICLE III – PURPOSE

The purposes for which the corporation is organized are exclusively religious and charitable within the meaning of section 501 ( c) 3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. This society shall be to provide In-depth Bible Teaching and study, Counseling, Church Services, Prayer and Hope for individuals and families. ARTICLE V – MANNER OF ELECTION





## ARTICLE- XI


