

ARTICLES OF INCORPORATION OF RIVER PASTURE SPORTSMAN'S CLUB, INC. A Florida Not For Profit Corporation

In compliance with the requirements of Chapter 617, Florida Statutes the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

ARTICLE I NAME

The name of the Corporation is: RIVER PASTURE SPORTSMAN'S CLUB, INC.

ARTICLE II EXISTENCE

The existence of the Corporation shall begin on: August 22, 2006.

ARTICLE III LOCATION

The street address of the principal office of the Corporation is:

ARTICLE IV PURPOSE

The specific purpose for which the Corporation is organized is: to promote the preservation of our nation's heritage of wild life sportsmanship and conservation through the formation and operation of a hunting club dedicated to these ideals. The activities of the hunting shall include:

(1) admission of an appropriate number of members having a significant interest in the advancement of safe hunting practices and wildlife conservation; (2) maintenance of a hunting club and the promotion of safe hunting practices; and, (3) advancement of hunting and sportsmanship.



ARTICLE V MANNER OF ELECTION OF THE BOARD OF DIRECTORS

The initial board of directors shall consist of three members. This number may be increased or decreased from time to time in accordance with the Not for Profit Corporation's bylaws, but shall never be less than one. Directors will be appointed by majority vote of the serving board of directors.
