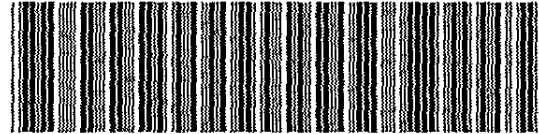




AMENDMENT TO ARTICLES
