**Articles of Incorporation of  
Centro Cultural Cristiano Chayil' Inc.**

The undersigned, acting as incorporator of a corporation under the Not for Profit Act of the State of Florida, Chapter 617, F.S. (Not for Profit) adopts the following Articles of Incorporation for such corporation:

**ARTICLE I:**

The name of the corporation, hereinafter referred to as the "Corporation", shall be Centro Cultural Cristiano Chayil', Inc.

**ARTICLE II:**

The principal office for the transaction of business of the Corporation shall be

Palm Bay, FL 32906

The mailing address of the Corporation shall be:

The Board of Directors may at anytime or from time to time change the location or the principal office from one location to another within the County of Brevard.

The territory in which the operations of the Corporation are principally to be conducted is the United States of America and its territories and possessions.

**ARTICLE III:**

The purpose for which the corporation is organized is exclusively for charitable, religious and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501©(3) of the Internal Revenue Service Code or corresponding section of any future Federal Tax Code. The Corporation may receive and administer funds for charitable, religious and educational purposes within the meaning of Section 501 © (3) of the Internal Revenue Service Code. The Corporation is empowered to hold any property or any undivided interest therein without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner, as in the judgment of the Directors, will best promote the purposes of the Corporation, no limitation except such limitations, if any, as may be contained in the instrument under which such property is received, then Articles of Incorporation, the By-Laws of the Corporation or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its Directors or Officers except as permitted under the Not for Profit Corporate Law.

Upon dissolution of the Corporation or the winding up of its affairs the assets of the Corporation shall be distributed exclusively to one or more charitable, religious or educational organizations which would then qualify under the provisions of Section 501 ©(3) of the Internal Revenue Service Code.

**ARTICLE IV:**

The Board shall consist of no more than nine (9) members and at least three (3) members, who need not be residents of the State of Florida. Directors shall be appointed of the President (Pastor.) The term of office of each director shall be one (1) year or until his successor is appointed. Vacancies shall be filled by appointment of the Pastor and ratified by Board of Directors then in office.

The Directors shall receive no compensation for their services as directors.


