**ARTICLE ONE
NAME**

The name of this corporation is Figure Skaters of Central Florida Future Champions Fund Inc.

**ARTICLE TWO
PRINCIPAL OFFICE AND MAILING ADDRESS OF THE CORPORATION**

The principal office and the mailing address of the corporation is 118 Springhurst Circle, Lake Mary, Florida 32746.

**ARTICLE THREE
STATEMENT OF CORPORATE NATURE AND PURPOSES**

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act set forth in Part I of Chapter 617 of the Florida Statutes.

Figure Skaters of Central Florida Future Champions Fund, Inc. will exist for the express purpose of fostering amateur athletes for competition in the sport of figure skating.

This corporation is organized exclusively for charitable, religious, educational and/or scientific purposes under Section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as tax-exempt organizations under that Code.

Notwithstanding any other provision of these Articles, the purposes will be limited exclusively to exempt purposes within the meaning of IRC 501(c)(3) and the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code; or (b) by a corporation, contributions to which are

deductible under Section 170(c)(2) of the Internal Revenue Code.

**ARTICLE FOUR
DEDICATION OF ASSETS**

The property of this corporation is irrevocably dedicated to fostering amateur figure skating by providing funding aimed towards competition in amateur national and international figure skating and by hosting fundraising events for that purpose.

No part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof.

**ARTICLE FIVE
INITIAL DIRECTORS**

There shall be three directors constituting the initial board of directors. The name and address of each person who is to serve as an initial director are:

**ARTICLE SIX
ELECTION OF DIRECTORS AND MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by the board of directors. Directors shall be elected by a majority vote of the then existing board of directors. The number of directors of the corporation shall be three; provided, however, that such number may be changed by an amendment to the bylaws and election by the existing board of directors.

**ARTICLE SEVEN
DISTRIBUTION OF ASSETS**

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation or corporation organized and operated exclusively benefiting amateur figure skating which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

**ARTICLE EIGHT
AMENDMENT OF ARTICLES**

Amendments to these Articles of Incorporation may be made by a resolution adopted by the Board of Directors.

**ARTICLE NINE
INCORPORATOR AND REGISTERED AGENT**

The name and address of the incorporator and incorporator is Cynthia A. Thomason, 118 Springhurst Circle, Lake Mary, FL 32746.

The undersigned, being the incorporator of this corporation, for the purpose of forming this nonprofit charitable corporation under the Laws of the State of Florida has executed these Articles of Incorporation this 2nd day of August 2006.
