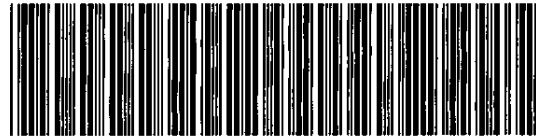

**ARTICLES OF INCORPORATION FOR
POWER FROM ON HIGH DELIVERANCE MINISTRY, INC.**

Article of incorporation of the undersigned, desiring to form a Church for non profit under chapter 617, Florida Statutes.

ARTICLE 1 - NAME OF THE CORPORATION

The name of the corporation shall be known as Power From On High Deliverance Ministry, Inc. hereinafter, referred to as "***The Church***".

ARTICLE 2 - DURATION

The period of its duration is perpetual, unless dissolved according to law.

ARTICLE 3 - PURPOSE AND OBJECTIVES

SECTION 1. PURPOSES

The purpose for which "***The Church***" is organized as follows:

PURPOSE (1) To establish this central and principal Church and Outreach Missions to be sanctioned by the principal Church throughout the United States of America and the territories thereof, and also throughout the universe, wherein and whereby the Glory of God, His son Jesus Christ, and the Holy Ghost may be extolled, revered, and proclaimed, in accordance with the Church.

PURPOSE (2) "***The Church***" is to inculcate and disseminate religious knowledge to the members and families in conformity with, discipline, rules, regulations, designated, formulated, promulgated, and established by the Board of Directors of the said principal Church: City of Miami, County of Dade.

PURPOSE (3) "***The Church***" is to hold special services, ministering the Word Of God in a practical way that can easily be understood and can be applied to every day life.

PURPOSE (4) "***The Church***" is to establish and maintain Outreach Missions, to engage in Homeless Outreach, Family Outreach, Prison Outreach, Nursing Home Outreach, Seniors Outreach, Youth Outreach, Daycare Outreach, After Care Outreach, Fitness Outreach, Parenting Outreach, and Bus Transportation Outreach. The Outreach Missions will provide training and support to individuals to be able to live and work independently in the community.

PURPOSE (5) "***The Church***" is to secure, plan layout, improve and maintain land to be used for the purpose of holding religious meetings, reunions and gatherings for the said members of said principal church and affiliate Outreach Missions.

PURPOSE (6) "***The Church***" is to have and to hold and to possess real and personal property either by purchase, leased or gift, to be used and employed for the purpose and objects of said corporate body, to mortgage and sell property and to contact for the reactions of institute building, for all other matters deemed advisable to promote and extend the functions and activities of the said body.

PURPOSE (7) "***The Church***" will make charitable contributions to Churches and other organizations actively engaged in Homeless Outreach, Family Outreach, Prison Outreach, Nursing Home Outreach, Seniors Outreach, and Youth Outreach.

PURPOSE (8) "***The Church***" is not for a private gain. No part of the net earnings of "***The Church***" shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that "***The Church***" shall be authorized and empowered to pay reasonable compensation for services rendered. To make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities

of *"The Church"* shall be the carry on of propaganda. Otherwise attempting to influence legislation and *"The Church"* shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any part of these articles. *"The Church"* shall not carry on any other activities not permitted to carry on. (A) By a corporation exempt from federal income tax under Section 501(C) (3) of the Internal Revenue Code, or the corresponding section of any future federal income tax code. (B) By a corporation, contributions to which are deductible under Section 170(C) (2) of the Internal Revenue Code, or the corresponding section of any future tax code.

SECTION 2. OBJECTIVES

- A. *"The Church"* is to teach and encourage humanity to worship, exalt, and obey Jesus Christ as Lord and Savior through acts of private and corporate worship and through their manner of living;
- B. *"The Church"* is to provide responsible Pastors, Evangelists, Ministers, and Influential Leaders an opportunity to project their message to a broader base than just their own organization and congregation. To provide preaching, teaching, and fostering the growth of the Christian faith to all peoples;
- C. *"The Church"* is to have the right to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise gain, dispose of or use such property, real or chattel, as may be required or beneficial for the good of *"The Church"*;
- D. *"The Church"* is to engage in a ministry of teaching and outreach through the Internet, publications, and other means of mass communication;
- E. *"The Church"* is to promote missionary work throughout the world. To bring believers and non believers to spiritual maturity;
- F. *"The Church"* is to collect, solicit and accept funds or other subscriptions to support *"The Church"*;
- G. To be *"The Church"* without capital stock and which does not contemplate pecuniary gain or profits for its members; and to pursue the purposes set forth in the Articles of Incorporation of *"The Church"*.

SECTION 3. *"THE CHURCH"* STATEMENT OF FAITH

BIBLE

We *"The Church"* believe that the Bible and the Bible alone is God's inspired and authoritative word to all people. The Word is the supreme authority for life and faith. It is sufficient to bring us to the knowledge of salvation. Is useful for teaching, rebuking, correcting and training righteousness. It alone is the final authority for determining all doctrinal truths. (2 Peter 1:20-21; 2Tim. 3:14-16; Ps 12:6; 119:160; Pr 30:5; Rom 16:25-26)

TRINITY

We *"The Church"* believe in one God, eternally existent in three persons: Father, Son (Jesus), and the Holy Spirit. These three are coequal and coeternal, and unchanging in mercy and grace. (Dt 6:4; 1Cor 8:6; Gn 1:1-26; Ex 34:6-7; Jn 10:30; Ps 90:2; Jn 1:1-14; Is 9:6)

JESUS CHRIST

We *"The Church"* believe that Jesus Christ is God the son, the second part of the Trinity. On Earth, Jesus, were fully man and fully God, being conceived by the Holy Spirit and born of the Virgin Mary. Jesus is the only man to have lived a sinless life. He is equal to God, his Father. We believe in Jesus' miracles, teaching, and that He offered Himself as the perfect sacrifice for the sins of all people by dying on the cross. We believe he rose from the dead after three days, having conquering sin and death. He ascended into heaven where he intercedes for us to the Father. Jesus will soon return again in power and glory to reign forever. (Rom 1:3-4; Mt 1:12; Titus 2:13; Acts 2:22-23; 1 Cor 15:4; Phil 2:5-11)

HOLY SPIRIT

We *"The Church"* believe the Holy Spirit is equal with God, the father and the son, Jesus Christ. The Holy Spirit makes us aware of our need for Jesus Christ by convicting us of our sins. The Holy Spirit lives in every person from the moment they accept Jesus as Savior and Lord, functioning as teachers, helper, and guide. The Holy Spirit provides the Christian with power for living a holy life, understanding the Scriptures, and doing what is right. The Holy Spirit gives the believer spiritual gifts for building up the church of Jesus Christ. (2 Cor 3:17; Acts 2:8; John 16:7-13; Gal 2:20; 1 Cor 2:12)

SALVATION

We "***The Church***" believe that salvation is the gift of God's grace and mercy. It cannot be earned or added to by good works. It is given to all who believe that Jesus Christ died on the cross for their sins. All who repent and believe in Jesus Christ as Lord and Savior are forgiven for their sins, and born into the family of God by the renewing work and power of the Holy Spirit. Eternal life begins the moment one receives Jesus Christ by faith. (Eph 2:8-9; Rom 6:23; Titus 3:5-7; Jn 3:16; Acts 16:30-33; Acts 2:38; Rom 10:9-10; Rom 5:1; 1 Jn 5:13)

ETERNITY

We "***The Church***" believe people were created to live forever. All people will experience the resurrection: believers to eternal life with God, unbelievers to eternal separation from God. Eternal life with God is heaven and eternal separation from God is hell. Heaven and hell are real places of eternal existence. (2 Cor 5:10; Gal 6:8; Rev 20:10-15, 21:8; 2 Cor 4:18)

SECOND COMING

We "***The Church***" believe Jesus Christ will physically and visibly return to earth for the second time to establish His Kingdom. This will occur at a date undisclosed by the Scriptures. (Mt 24:30, 26:63-64; Acts 1:9-11; 1 Thess. 4:15-17; 2 Thess. 1:7-8; Rev. 1:7)

GREAT COMMISSION

We "***The Church***" believe in the great commission set forth by Jesus to go into the world preaching the gospel and making disciples. Baptizing them in the name of the father, Son, and Holy Spirit and teaching them to obey everything that He has commanded. (Mt 28:19-20; Mk 16:15)

THE CHURCH

We "***The Church***" believe the church is the Body of Christ, the habitation of God through the Spirit, with divine appointments for the fulfillment of Jesus' Great Commission. Every person born of the Spirit is an integral part of the church as a member of the Body of believers. There is a spiritual unity of all believers in our Lord Jesus Christ. (Jn 17:11,20-23; 1 Cor 12:12-31; Eph 1:22, 2:19-22; Heb 12:23)

ARTICLE 4 - CORPORATION DISSOLUTION

The Corporation Dissolution of Assets, upon the dissolution or winding up of "***The Church***", its assets remaining after payment or provision for payment of all debts and liabilities of "***The Church***", shall be disposed of by the Board of Directors of Body of Christian Believers Ministry, Inc. in which is affiliate with the "***The Church***" located in Dade County, Florida, an exclusively religious and charitable purpose organization, as said Ministry shall determine, which has established its tax exemption status under Section 501(C)(2) and 170(C)(2) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE 5 - PRINCIPAL PLACE OF BUSINESS

SECTION 1. PRINCIPAL OFFICE

The principal office of "***The Church***" for the transaction of its business is fixed and located at 5410 A N.W. 14th Avenue, Miami, Florida 33142

SECTION 2. CHANGE OF ADDRESS

The address of "***The Church***" principal office can be changed only by amendment of these Bylaws and not otherwise. The Board of Directors may, however, change the principal office from one location to another within the named county by noting the change address and effective date below, and such changes of address shall not be deemed an amendment of these Bylaws.

SECTION 3. OTHER OFFICES

"The Church" may also have offices at such other places, within or without the State of Florida, where it is qualified to do business, as its business may require and as the Board of Directors may, from time to time, designate.

ARTICLE 7 - OFFICERS

ARTICLE 8 - MANNER OF ELECTION

New Directors in *"The Church"* will be elected in the following, three step, and manner; first, they must have a unanimous nomination by the current directors. Second, they must be approved by a majority decision of the leaders. Finally, they must be approved by a majority decision of the Board of Director's.

ARTICLE 10 - CAPITAL STOCK

"The Church" shall have no capital stock and shall be composed of Church Members rather than shareholders.

ARTICLE 11 - QUALIFICATIONS OF CHURCH MEMBERS

The qualifications for Church Members and manner of admission shall be as set forth in and regulated by the By Laws of *"The Church"*.

ARTICLE 12 - VOTING RIGHTS

Church Members of *"The Church"* will have no voting rights as are provided in the By Laws of *"The Church"*.

ARTICLE 13 - LIABILITIES FOR DEBTS

Neither the church members nor the members of the Board of Directors or Officers of *"The Church"* shall be liable for the debts of the *"The Church"*.

ARTICLE 14 - REGISTERED OFFICE AND REGISTERED AGENT

The initial address of registered office of *"The Church"* is 5410 A N.W. 14th Avenue, Miami, Florida 33142. The name and address of the registered agent of *"The Church"* is Pastor Barbara A. McDuffie, located at 5410 A N.W. 14th Avenue, Miami, Florida 33142.


ARTICLE 15 - EFFECTIVE DATE


These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.


