ARTICLES OF INCORPORATION OF

The undersigned, desiring to form a charitable corporation under the non-profit corporation law of Florida, Chapter 617, Florida Statutes, and as hereinafter amended, hereby certifies:

ARTICLE I

Name

The name of this corporation shall be COMMUNITY HOPE CENTER, INC.

ARTICLE II

Principal Office

The mailing address of the Corporation shall be 301 East Broward Boulevard, Fort Lauderdale, FL 33301.

ARTICLE III

Purposes

Section 1. The Corporation is organized exclusively for all purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code").

Section 2. Without in any way limiting the foregoing general purposes, the specific purposes of the Corporation shall be to provide a cross-cultural, holistic system of service in order to empower individuals and families to lead more productive and fulfilling lives.

ARTICLE IV

Directors

The management of the Corporation shall be vested in a Board of Directors. The number of

Directors, their terms of office, and how they are to be elected or appointed shall be fixed by the By-Laws of the Corporation, and may be altered by amending the By-Laws.

ARTICLE V
Membership

The conditions and terms of, and the qualifications for membership in the Corporation shall be provided for in the By-Laws. Members, Directors and Officers of the Corporation shall have no personal liability for corporate obligations.

ARTICLE VI
Registered Office and Agent

The street address of the Registered Office of the Corporation is: 301 East Broward Boulevard, Fort Lauderdale, FL 33301; and the name of the Registered Agent for the Corporation located at the address of the Registered Office is Dr. Millicent Lindo.

ARTICLE VII
Incorporator

The name and address of the Incorporator of this Corporation is Dr. Millicent Lindo, 301 East Broward Boulevard, Fort Lauderdale, FL 33301.

ARTICLE VIII
Distribution on Liquidation or Dissolution

In the event of Liquidation or Dissolution or winding up of the Corporation, whether voluntary or involuntary or by operation of law, the remaining property and assets of the Corporation shall be distributed to the First Baptist Church of Fort Lauderdale, Inc., but none of the property or assets of the Corporation or any proceeds thereof shall be distributed for purposes other than one or more of the exempt purposes specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as that section may, from time to time hereafter, be amended.

ARTICLE IX
Amendment to Articles of Incorporation

These Articles of Incorporation may be amended by the Directors in accordance with the procedure set forth in its By-Laws. However, with regards to dissolution of the Corporation, no amendment shall take place to allow or cause distribution to any entity which is not exempt from taxation under Section 501(c)(3) of the Code.

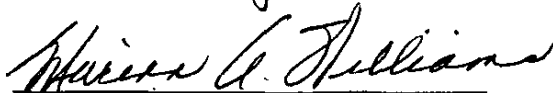
