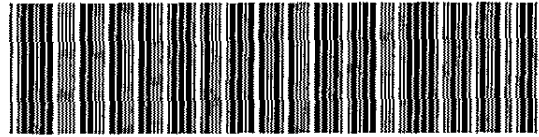

We do hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to not-for-profit corporations, and form ourselves and our successors into a not-for-profit corporation pursuant to Chapter 617.0202 of the Florida Statutes, we the undersigned do set forth the following Articles of Incorporation:

**ARTICLE I**

The name of this corporation shall be NEW LIFE BIBLE INSTITUTE, INCORPORATED.

**ARTICLE II**

The principle place of business shall be 5809 Neal Drive, Tampa, Florida 33617. The mailing address for the business shall be P.O. Box 16371, Temple Terrace, Florida 33687-6371.

**ARTICLE III**

The Corporation is organized exclusively for religious purposes, including without limitations, the following

- a) To provide a meaningful and organized structure and physical facility to accommodate public teaching of the Lord Jesus Christ, enabling persons of all races, creeds and colors to learn together as a body of believers, committed to the Word of Jesus Christ;
- b) To pledge itself in unselfish devotion and loyalty to the principles and doctrines of the Christian faith;
- c) To encourage students to be representatives of holiness in their everyday lives through applying Biblical principles, and to live lives that reflect the image of Christ, by associating together as a body of believers for the purpose of religious education, and for the dissemination of the Gospel of Jesus Christ;
- d) To disseminate the Gospel of Jesus Christ, as set forth on the Holy Scriptures as recorded in the Bible, which is believed to be the inspired, infallible and unerring Word of God;
- e) To teach, preach, evangelize, facilitate and accommodate Biblical education, and to promulgate the Gospel of Jesus Christ, through all available lawful means, whether through electronic and digital media (television or radio or Internet), through written or verbal communication, or through evangelistic outreaches to hopeless and despairing individuals of all races, creeds, and colors.
