JCPWE-FL ANNUAL REPORT

JCPWE-FL was incorporated in the month of September 2006 in the State of Florida. The primary function of this incorporation is to provide worldwide evangelism crusades and conferences, workshops relating to soul winning into Christ Kingdom, prayer, healing, and deliverance ministration. The vision of this corporation is to unite and support the entire Body of Christ worldwide, mainly reaching souls for the Kingdom of God with the gospel of Jesus Christ and connecting them to local places and churches in their area. The month of September was filled with follow-up from the Conference that was birthed in Hollywood, FL in August, 2006. The evangelism work started out in the State of Florida by the founding President Evangelist John Deby Edukugho and his team to different churches, culminated in Conferences, Workshops and invitations to other cities and overseas countries for crusades and revival meetings.

The month of October was a time of transition as Susan Torres, the local Coordinator for JCPWE-FL relocated to Central Florida along with her husband. After a time of prayer and divine guidance, the establishment of a DIRECTORATE was put into place to break up the functions previously overseen by Mrs. Torres to accommodate the growth of the ministry. The confirmed DIRECTORATE as of November 1, 2006 consists of Bro. Ricky Bookal - Chief Servant of God, presiding; Brother Derrick, Deputy, Sister Angie Bynes, Secretary, Sister Gloria Atkinson, Member. Mrs. Torres continues to be a part of the incorporation along with the confirmed directorates mentioned above. From October to year end, it's been a time of building more relationships in the community with ministries, and individuals. The JCPWE-FL JESUS POWER CRUSADE took place July 20-22, 2007. There are also Crusades in Brooklyn, NY and Chicago, IL along with various revival meetings by the President Evangelist John Deby Edukugho in Tampa (Florida), Blytheville (Arkansas), and Dallas (Texas).

Another operational arm of this ministry is the Prayer Line, where many Christians and our Partners from various States nationwide meet via a phone call in conference for prayer regularly. Susan Torres and Ricky Bookal have been coordinating this arm of the ministry, until now.
