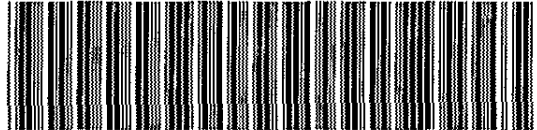

ARTICLES OF INCORPORATION
OF
SAVE OUR EVERGLADES TRUST, INC.

ARTICLE I – NAME

The name of this Corporation shall be SAVE OUR EVERGLADES TRUST, INC.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business address of this corporation shall be: 11 DeLeon Avenue, Islamorada, Florida, 33036 and the mailing address of P. O. Box 1915, Islamorada, FL 33036.

ARTICLE III - PURPOSE

The Corporation shall be organized as a not-for-profit corporation under chapter 617, Florida Statutes. The Corporation is organized and the purpose of the Corporation is to engage in exempt function activity as described in Section 527 of the Internal Revenue Code of the United States, which activities are exempt from taxation under such section. No part of the Corporation's earnings shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purpose.

ARTICLE IV – MANNER OF ELECTION

The Directors will be elected or appointed as provided in the By-Laws.

ARTICLE VI – INITIAL DIRECTORS AND/OR OFFICERS

The initial Board of Directors shall consist of three members. The name and street address of the members of the initial Board of Directors of the Corporation, who shall hold office until the first annual meeting of the members, and thereafter until their successors have been

ARTICLE VIII – DISSOLUTION OF ASSETS

The Corporation shall exist perpetually unless dissolved according to law. Upon dissolution of the corporation, assets may be distributed to a nonprofit fund, foundation, or corporation that is organized exclusively for either charitable or social welfare purposes, having established its tax exempt status under either Section 501(c)(3) or 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or may be distributed to a state or local government, for a public purpose.

Upon dissolution of the Corporation, contributions to the Corporation, exclusive of earnings, may be distributed on a pro rata basis based upon original contribution amounts to the original contributor.
