Article VIII

The Corporation shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Church of Alexandria adopted by the Synodical Committee for the Coptic Churches in Immigration or contrary to the policies of the Bishop of the Coptic Orthodox Diocese of the Southern United States.

Article IX

The Coptic Orthodox Church defines marriage as one of the seven Mysteries (Sacraments) of the Church, officiated by a consecrated Coptic Orthodox bishop, priest or both (or other Orthodox bishop, priest or both, who is/are in full communion with the Coptic Orthodox Church) in good standing, uniting one man and one woman. The Coptic Orthodox Church defines a man as a human being having the reproductive sexual organs of a male from birth, and the Coptic Orthodox Church defines a woman as a human being having the reproductive sexual organs of a female from birth.

Article X

The Coptic Orthodox Church shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Orthodox Church of Alexandria adopted by the Holy Synod of the Coptic Orthodox Church as well as the Synodical Committee for the Coptic Orthodox Churches in the land of Immigration.
