

ARTICLES OF INCORPORATION MARGATE MORAVIAN CHURCH, INC.

26 146 30 PM The undersigned, acting as Incorporator for the purpose of forming a corporation in? compliance with Florida Statutes, Chapter 617, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME

The name of the corporation shall be MARGATE MORAVIAN CHURCH, INC.

ARTICLE II PRINCIPAL OFFICE
