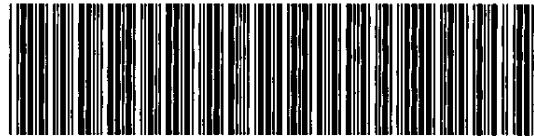

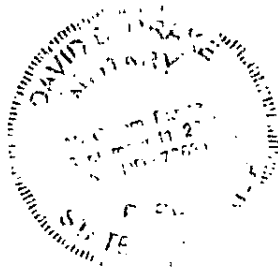

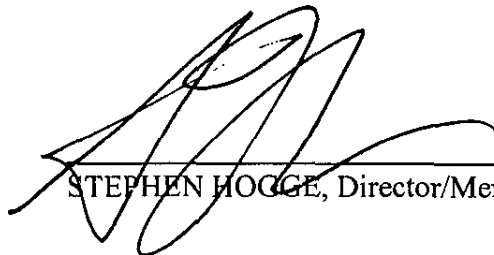

UNANIMOUS CONSENT OF THE MEMBERS
AND DIRECTORS OF CITIZENS FOR PROPERTY TAX RELIEF, INC.

Pursuant to the authority of Section 617.0701, Florida Statutes, the undersigned, being the sole member and Director of Citizens for Property Tax Relief, Inc., a Florida nonprofit corporation (the "Corporation"), does hereby waive the necessity of an organizational meeting and in lieu thereof, does affirmatively vote for, consent to, adopt, and approve the following resolutions:

1. In the judgment of the member and Board of Directors it is desirable for business reasons to dissolve the corporation.
2. The corporation is currently engaged in efforts to minimize property tax in Florida.
3. It is the intention of the parties to dissolve the corporation.
4. The Articles of Dissolution is hereby, in all respects, approved and ratified substantially in the form set forth in Exhibit "A" hereto.
5. The member or Director of the Corporation is authorized, empowered, and directed to do and perform all such further acts and things, to execute and deliver in the name of the Corporation, and where necessary or appropriate, to file with the appropriate governmental authorities, all such further certificates, instruments, or other documents, as in their judgment shall be necessary or advisable in order to effectuate the dissolution.
